Toronto Local Appeal Body – Members Discussion Session

Summary

This is an opportunity to raise matters of interest arising from the Hearing process or matters of general interest. Topics include the following:

- C) Administrative Dismissal of Applicants Outstanding Undertakings, with Notice (Member Lord)
- C) Admissibility: OPA 320; Growth Plan (Member Gopikrishna)

Decision Advice and Other Information

A) TLAB Administration currently has a draft version of the *Commentaries on the Hearing Process*. Ian Lord, TLAB Chair, request to have the Notice of Hearing to include a line that encourages mediation (within the framework) as well as in the Public Guide. TLAB must look into whether the settlement decisions protects the Public's interest and not just the Parties, as most reviews being submitted are addressing whether the Panel Member has addressed all the test.

B) Ian Lord, TLAB Chair, suggest the consideration be made for somewhat like circumstances Appeals, as to ignore them is the risk that generates discontent within the public – so consistency is a virtue. The TLAB is having Appeals of similar nature that have been dealt with previously repeat in a newly filed Appeal, they are easily identifiable and perhaps with assistance from staff some search efforts can be made.

C) Ian Lord, TLAB Chair, states there are some instances of extreme delay in motivating representatives to submit documents that were to be submitted after the conclusion of the hearing. The Chair is looking for assistance in motivating the completion of undertakings. Discussions regarding using a Response Letter/Notice to Request Outstanding Submissions.

C) S. Gopikrishna, TLAB Panel Member, withdraws this item as it was brought up in a different context – issue resolved.

D) Ian Lord, Chair of TLAB states to be alert to the fact that the Appeal may be applied to the old or the new Rules, and to act accordingly.

E) S. Gopikrishna, TLAB Panel Member, add on item to discuss having additional meeting dates, notably a meeting every two months. D. Lombardi, TLAB Vice Chair, suggest a consecutive second day. T. Yao, TLAB Panel Member, not in favour of having more meetings. S. Makuch, TLAB Panel Member, is in favour of more meetings. TLAB staff to look into schedule regarding additional meeting dates, states easier to book two consecutive in advance and then cancel the second date if it is not needed – two month interval would be easiest for Administrative staff to accommodate.
