DECISION:

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"Vehicle-For-Hire Driver's Licence and Taxicab Owner's Licence will be renewed, subject to the following conditions:

The Tribunal ordered amendments to conditions 1 and 2, on consent:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 60 days of the Tribunal hearing, failing which the licences may be cancelled;
- (2) Michael Davindra Seunarine's Vehicle-For-Hire Driver's Licence and Taxicab Owner's Licence will be renewed and suspended for Three (3) days, starting on January 28, 2021 at 12:00 p.m. until January 31, 2021 at 12:00 p.m.;

- (3) The Vehicle-For-Hire Driver's Licence and Taxicab Owner's Licence will be placed on probation for a period of Three (3) years. Michael Davindra Seunarine is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Michael Davindra Seunarine and conduct other investigations, as appropriate, to assess Michael Davindra Seunarine's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Michael Davindra Seunarine or any other concerns with respect to the conduct of the licensee, those matters and report no. 7415 and any updating material, may be brought back before the Tribunal for a full hearing."
