## TORONTO LICENSING TRIBUNAL ELECTRONIC HEARING: February 18, 2021 (1:00 PM) Summary of Decisions M. Laverty / V. Francis / E. Montigny

1. Mohamed Abdirashid Farah (Report No. 7398) Holder of Tow Truck Driver's Licence No. D09-4974475

## **DECISION:**

The Tribunal approved the joint Interim Resolution signed on February 18, 2021, as follows:

(1) "The Tribunal proceeding in this matter shall be adjourned to a date in April 2021, or as soon as possible thereafter;

The Parties also agree to the following interim conditions to be place on the Tow Truck Driver's License:

- (1) Mohamed Abdirashid Farah ("Mr. Farah") shall inform Municipal Licensing and Standards (MLS) of any disposition of the outstanding charges under Chapter 545 of the Municipal Code, the Highway Traffic Act and the Compulsory Automobile Insurance Act, in writing, within three (3) business days.
- (2) Mr. Farah shall inform MLS of any new criminal, Highway Traffic Act, Compulsory Automobile Insurance Act, and by-law charges laid against him, in writing, within three (3) business days.
- (3) Mr. Farah can notify MLS of the information referred to in conditions 1 and 2, above, in one of the following ways:

## 2. Sukhwant Singh Mahal (Report No. 7414)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-2902773 AND

Applicant for the Renewal of Taxicab Owner's Licence No. V02-4725381

## **DECISION:**

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"Vehicle-For-Hire Driver's Licence and Taxicab Owner's Licence will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) The Vehicle-For-Hire Driver's Licence and Taxicab Owner's Licence will be placed on probation for a period of Two (2) years. Sukhwant Singh Mahal is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Sukhwant Singh Mahal and conduct other investigations, as appropriate, to assess the Sukhwant Singh Mahal's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next <u>Two</u> (2) renewal(s) of the licence, Sukhwant Singh Mahal must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Sukhwant Singh Mahal or any other concerns with respect to the conduct of the licensee, those matters and report no. 7414 and any updating material, may be brought back before the Tribunal for a full hearing."
