## **DECISION:**

The Tribunal approved the joint Proposed Resolution, originally signed on March 3, 2021, as follows:

"Taxicab Owner's Licenses will be renewed and Toronto Taxicab Owner's Licence will be subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Taxicab Owner Licenses and Toronto Taxicab Owner's Licence will be placed on probation for a period of <u>Two</u> (2) year. Dimarco Taxi Ltd. is advised that during the probationary period, MLS may make additional checks of any criminal, and by-law charges and convictions against Dimarco Taxi Ltd. and conduct other investigations, as appropriate to assess the Dimarco Taxi Ltd.'s compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Dimarco Taxi Ltd. or any other concerns with respect to the conduct of the licensee, those matters and report no. 7341 and any updating material, may be brought back before the Tribunal for a full hearing."

## DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on March 3, 2021, as follows:

"Taxicab Owner's License will be renewed, subject to the following conditions:

 All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;

The Tribunal ordered an amendment to condition 2, on consent:

- (2) 1546021 Ontario Inc. Taxicab Owner's License will be renewed and suspended for <u>One</u> (1) days. The suspension shall be in effect from 12:01am on the first Friday following the Tribunal's order, and shall continue until 11:59pm **on the same day**;
- (3) Taxicab Owner License will be placed on probation for a period of <u>Two</u> (2) year. 1546021 Ontario Inc. is advised that during the probationary period, MLS may make additional checks of any criminal, and by-law charges and convictions against 1546021 Ontario Inc. and conduct other investigations, as appropriate, to assess 1546021 Ontario Inc.'s compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against 1546021 Ontario Inc. or any other concerns with respect to the conduct of the licensee, those matters and report no. 7477 and any updating material, may be brought back before the Tribunal for a full hearing."
