TORONTO LICENSING TRIBUNAL ELECTRONIC HEARING: February 25, 2021 (1:00 PM) Summary of Decisions D. Simon / M. Lee / P. Turtle

1. 1808831 Ontario Inc. (Report No. 7462)

o/a Green Leaf Health Centre Feng Ying Qian, President Holder of Holistic Centre Licence No. B30-3960012 AND Feng Ying Qian o/a Tui-Na Health Clinic Applicant for a Holistic Centre Licence (Application No. C015451) AND Feng Ying Qian

Applicant for the Renewal of Holistic Practitioner Licence No. T30-3595543

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on February 24, 2021, as follows:

"The business licences Licence No. B30-3960012 (a Holistic Centre Licence) and Licence No. T30-3595543 (a Holistic Practitioner Licence) will be renewed, and the Holistic Centre Licence (pursuant to Application No. C015451) will be issued effective immediately (collectively the "Licences"), subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the Licences may be cancelled;
- (2) The Licences will be suspended for fourteen (14) consecutive days, commencing on the first day holistic centres are permitted to open for business in Toronto, following the current public health closure;
- (3) The Licences will continue on probation for a period of three (3) additional years until March 1, 2024. The Licensees are advised that during the probationary period, MLS may make additional checks of any criminal, and by-law charges and convictions against the Licensees and its director, and conduct other investigations, as appropriate, to assess the Licensees' compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;

(4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against the Licensees, their director, or any other concerns with respect to the conduct of the Licensees and their director, those matters and report no. 7462 and any updating material, may be brought back before the Tribunal for a full hearing."

2. Brandon Norbert Galloro (Report No. 7371)

Applicant for a Tow Truck Driver's Licence (Application No. B972893)

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on February 10, 2021, as follows:

"Tow Truck Driver's Licence will be issued to Brandon Norbert Galloro, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, the Tow Truck Driver's Licence will be placed on probation for a period of three (3) years. Brandon Norbert Galloro is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Brandon Norbert Galloro and conduct other investigations, as appropriate, to assess Brandon Norbert Galloro's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Brandon Norbert Galloro or any other concerns with respect to the conduct of the licensee, those matters and report no. 7371 and any updating material, may be brought back before the Tribunal for a full hearing."
