### Innes Avenue Pedestrian Bridge Rehabilitation


#### Contract: 21ECS-TI-06BE Start Date: July 2021 End Date: February 2022 \*Timeline is subject to change.

The City of Toronto is planning to rehabilitate the Innes Avenue pedestrian bridge over the Metrolinx tracks in Spring 2021. This work will ensure that this bridge meets today's standards and remains safe for pedestrians into the future. <u>The bridge will remain closed to pedestrians for the duration</u> <u>of construction</u>. The project is part of the Council-approved 2021 Capital Works Program.

#### IMPORTANT INFORMATION ABOUT COVID-19 AND CONSTRUCTION WORK IN TORONTO

#### WHAT TO EXPECT BEFORE CONSTRUCTION

- Work crews will mark the locations of underground utilities, such as gas, water and cable so that the construction work does not interfere with these utilities.
- Affected properties will receive a Construction Notice approximately two weeks before work begins with more information about the work.

### **Pre-Construction Notice**

	<b>Work Hours</b> : Work will take place from 7 a.m. to 11 p.m., Monday to Friday, and from 7 a.m. to 7 p.m. on weekends.	
	Additionally, due to Metrolinx occupancy restrictions and daytime train schedule, there will be a period of approximately two months where the work will need to be completed overnight during Metrolinx's non-service window. Affected properties will receive a Construction Notice approximately two weeks before work begins with more information about the overnight work hours.	
	<b>Important information for owners of sprinkler systems / fences/ shrubs and private landscaping features within City property.</b> In order to complete work on this bridge, crew may need to remove encroachments of private items, such as fences and shrubs, within the public right-of-way.	
<u>AA AA</u>	Affected properties will receive a separate letter from the Project Manager with more information.	
Ġ	Accessible Accommodation: Residents who require accommodation (level entry, longer notice, etc.) must contact the Field Ambassador to arrange for access during the construction period.
