1. Mohammad Shafiq Gharwal (Report No. 7568)

Holder of Vehicle-For-Hire Driver's Licence No. D01-3134579 AND

Holder of Taxicab Owner's Licence No. V02-4670889, Plate No. 2766

#### **DECISION:**

The Tribunal approved the joint Proposed Resolution signed on March 25, 2021, as follows:

"Taxicab Owner's Licence and Vehicle-For-Hire Driver's Licence be issued subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licences may be cancelled:
- (2) The Vehicle-For-Hire Driver's Licence and Taxicab Owner's Licence will be placed on probation for a period of Three (3) years. Mohammad Shafiq Gharwal is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mohammad Shafiq Gharwal and conduct other investigations, as appropriate, to assess Mohammad Shafiq Gharwal's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next <u>Three</u> (3) renewal(s) of the Vehicle-For-Hire Driver's Licence, Mohammad Shafiq Gharwal must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mohammad Shafiq Gharwal or any other concerns with respect to the conduct of the licensee, those matters and report no. 7568 and any updating material, may be brought back before the Tribunal for a full hearing.
