Road Resurfacing in Scarborough-Guildwood

Contract: 21ECS-TI-15LR

Start Date: May 2021 End Date: November 2021

The City of Toronto will resurface the streets listed below. Our inspection of these roads shows that they need resurfacing and sections of damaged curb and/or sidewalk need to be replaced to bring them to a state of good repair.

This project is part of the Council-approved 2021 Capital Works Program to renew aging City roads and sidewalk for current and future needs.

This notice contains important information about the work. **Please save this notice for your records.**

A Construction Notice with start and end dates will be distributed approximately two weeks before the work starts. Construction Notices will also be available on the City's website at toronto.ca/scarboroughguildwood.

IMPORTANT INFORMATION ABOUT COVID-19 AND CONSTRUCTION WORK IN TORONTO

AFFECTED STREETS IN SCARBOROUGH-GUILDWOOD

Work will take place for the following sections of roads:

- Apsco Avenue
- Brewton Road
- Clementine Square
- Fareham Crescent
- Ingrid Drive from Greenock Avenue to Slan Avenue
- Indian Mound Crescent
- Greencedar Circuit and Daphne Road intersection
- Rowatson Road
- Toulon Road











WORK DETAILS




The City's contractor will:

- Dig up the road surface
- Re-align maintenance holes and catch basins
- Repair sidewalks and/or curbs and gutters
- Repave the road surface

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property.

	<p>Work Hours: Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.</p>
	<p>Accessible Accommodation: Residents who require accommodation (level entry, longer notice, etc.) must contact the Field Ambassador to arrange for access during the construction period.</p>
	<p>Important information for owners of sprinkler systems / heated driveways and private landscaping features. Property owners should remove items located within City property limits (boulevard) to avoid damage.</p> <p>This includes items such as landscaping (plants and pavers), decorative objects, sprinkler systems or heated driveways. If you have a sprinkler system or heated driveway, please contact the Field Ambassador listed below.</p>
	<p>Telephone and Internet Services: This work may affect phone and internet cables for individual properties that aren't buried deep below the sidewalk. The contractor will coordinate with utility companies to minimize disruption. Residents who find their service has been disrupted should contact the Field Ambassador <u>and</u> notify their phone or internet service provider.</p>
	<p>Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the work zone. Access for emergency vehicles will be maintained at all times.</p> <p>Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.</p>
	<p>Traffic Management: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users.</p> <p>Traffic will be reduced on streets with active construction and access may be limited when paving operations are taking place.</p>
	<p>Site Safety: Workers on site are responsible for the work assigned to them. If you have construction questions or an issue on site – ask to be directed to the site inspector. If the site inspector is unavailable, contact the Field Ambassador listed on this notice.</p>
	<p>Physical Distancing: There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility clothing and will maintain physical distancing.</p>
	<p>Parking: This project will affect on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.</p>
	<p>Parking Violation Notice: If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, do the following within 15 days of the notice date:</p> <ol style="list-style-type: none"> 1) Contact the site inspector or person listed on the Construction Notice and give them the yellow notice number. 2) Dispute the parking violation notice online or in person following the process listed on the back of the parking violation notice.

	<p>You may use this construction notice as part of the explanation of why the violation should be cancelled. Please note: violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in no parking zones).</p> <p>In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction and may need to temporarily park on your street.</p>
	<p>Garbage and Recycling: Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. Please ensure that you label your bins with your address.</p>
	<p>Restoration: The construction work area will be restored with sod, concrete and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).</p>
	<p>Asbestos in Asphalt on some streets in Scarborough-Guildwood: As part of the work, the City must test the removed asphalt for asbestos. Our tests show that there is asbestos in the asphalt on Fareham Crescent, Indian Mound Crescent, Rowatson Road and Toulon Road.</p> <p>Asbestos was used in asphalt mixes throughout the 1970s and early 1980s to improve the performance of the asphalt. Air quality monitoring conducted by the City of Toronto at other sites has not detected asbestos fibres in the air as a result of resurfacing asphalt. The risk of exposure to asbestos for workers and bystanders is low.</p> <p>As a precaution, the City requires the contractor to follow these steps:</p> <ul style="list-style-type: none"> • Wet the pavement during asphalt cutting, grinding or removal, • Attach dust collecting devices with HEPA filters to equipment, where possible, to prevent dust from becoming airborne, • Provide personal protective equipment (disposable coveralls and respirators) to on-site workers, and • Transport and dispose of asphalt containing asbestos to provincially approved disposal sites.
