Road Resurfacing on Forest Hill Road and Kilbarry Road

Contract: 20ECS-TI-13LR Start Date: April 5, 2021 End Date: July 9, 2021 *Timeline is subject to change.

In 2020, the City resurfaced Forest Hill Road and Kilbarry Road. As part of the Vision Zero Road Safety Plan, the City's contractor will return to implement a number of effective road safety measures to help create better sight lines for pedestrians, cyclists, and drivers, shorten pedestrian crossing distances and encourage drivers to move at the speed limit. The measures will be installed at the Forest Hill Road and Kilbarry Road intersection.

The improvements are part of the Council-Approved 2020 budget and the City's Vision Zero Road Safety Plan that aims to create a safe and healthy city by eliminating all fatalities and serious injuries on city streets.

Construction Update #1

PLANNED ROAD SAFETY IMPROVEMENTS

INTERSECTION NORMALIZATION	 Irregular intersections (e.g. Skewed, offset or complex) are reconfigured to: Increase visibility and shorten crossing distances for pedestrians Lower vehicle speeds from smaller turning radii.
CURB RADII REDUCTIONS	 The curb radii is the curved section that connects two intersecting streets. Reducing curb radii can: Deter drivers from making right turns at high speeds Improve pedestrian crossing distances and visibility Increase the space available for pedestrians waiting to cross.
CURB EXTENSIONS	 Curb extensions, also known as bump-outs, reduce the pavement width at intersections by extending the curb into the roadway. They help to: Reduce crossing distance and time a pedestrian is exposed to traffic Increase visibility of users Physically and visually narrow the road, slowing vehicles.
