### New Sidewalk Installation on Commissioners Street from Logan Avenue to Leslie Street

Contract: 20ECS-TI-02SP Original Start/End Date: October 21, 2020/November 30, 2020 Revised End Date: April 2021 \*Timeline is subject to change.

In April, following the winter break, the City will resume installing new sidewalks on the north side of Commissioners Street from Logan Avenue to Leslie Street. Sidewalks are a critical piece of transportation infrastructure which provide accessibility and safety for all, including vulnerable road users. Our data shows that the north side of Commissioner Street from Logan Avenue to Leslie Street is missing a portion of sidewalk.


Access to properties along Commissioners Street from Logan Avenue to Leslie Street will be maintained during construction.

This project is part of the Council-approved 2020 Capital Works Program. Installing new sidewalk is one way the City is committed to making the community safer and more accessible.

### WORK DETAILS

The City's contractor will:

- Mark the area where the new sidewalk will be installed on City-owned land (Right-of way)
- Dig out the marked area
- Install granular base
- Form the area for new sidewalk bays
- · Pour concrete and install tactile plates where required
- Remove forms
- Restore areas affected by construction

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.

Please note: violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in no parking zones).</li> </ul> |  |
