1. Khaled Gamal Hegazy (Report No. 7447)

Applicant for the Renewal of Tow Truck Driver's Licence No. D09-4808825

DECISION:

The Tribunal approved the request for adjournment to April 8, 2021 at 1:00 p.m., on consent.

The Tribunal further approved the following interim condition be placed on Mr. Hegazy's Tow Truck Driver's Licence, on consent:

(1) The Tow Truck Driver's Licence will be suspended on an interim basis, effective immediately, and will remain in place until this matter is before the Tribunal on April 8, 2021 and the Tribunal orders otherwise.

2. Ismail Mohammad (Report No. 7426)
Holder of Vehicle-For-Hire Driver's Licence No. D01-4654441

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on March 3 and March 4, 2021, as follows:

"Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence may be cancelled;
- (2) The Vehicle-For-Hire Driver's Licence will be suspended for **five** (5) consecutive days. The suspension shall be in effect from 12:01 a.m. on the first Friday following the Tribunal's order to renew the Vehicle-For-Hire Driver's Licence and shall continue until 11:59 p.m. on the first Tuesday thereafter;

- (3) Immediately upon being renewed, the Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years. The Licensee is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against the Licensee and conduct other investigations, as appropriate, to assess the Licensee's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against the Licensee or any other concerns with respect to the conduct of the licensee, those matters and report no. 7426 and any updating material, may be brought back before the Tribunal for a full hearing."
