## Weir Removal, Channel Improvements & Sewer Connections Crossing East Don River

**Notification Period: April 28 2021 to May 31, 2021**

The City of Toronto plans to remove a concrete weir, install four new sewer connections and carry out channel improvements in the East Don River located in East Don Parkland. The proposed works will occur on Toronto and Region Conservation Authority (TRCA) owned property under management agreement with the City of Toronto. Please see the information provided on the reverse side for this project's notification following Transport Canada's *Canadian Navigable Waters Act*.

The City of Toronto and TRCA hereby gives notice that a submission has been added to the Navigable Waters Registry pursuant to the *Canadian Navigable Waters Act* for public comment described herein and its site and plans.

Pursuant to paragraph 10(1)(b) of said Act, the City of Toronto and TRCA has deposited with the Minister of Transport on the on-line Common Project Search Registry (<http://cps.canada.ca/>) and under registry number **#NPP 3321** a description of the following work, its site and plans:

- Location: 1240 Sheppard Avenue East, at the north-west corner of Leslie Street in the East Don Parkland (Property Ownership: Toronto and Region Conservation Authority owned property under management agreement with the City of Toronto).
- Plans include:
  1. The removal of an outflanked concrete weir located in the East Don River
  2. The replacement of an undersized sanitary sewer connection under and across the East Don River
  3. The installation of two (2) forcemain sanitary sewers and one (1) sanitary sewer connection under and across the East Don River
  4. Impacted sections of the river will be remediated using natural channel designs which also includes river bed & river bank stabilization
- Additional information:
  - An open cut trench from the East Don Trunk Sewer (parallel with Leslie Street) to Sheppard Avenue East through the East Don Parkland parking lot will be used to install the sewers crossing the river
  - The two forcemains and sanitary sewer will connect to a future/proposed underground storage tank below the parking lot
  - Removal of the obstruction caused by the outflanked concrete weir will provide long term improvements to water flow and river navigation
