### Mill Street Bridge Rehabilitation over West Don River


#### Contract: 21ECS-TI-11BE Start Date: May 25, 2021 End Date: December 2021 \*Timeline is subject to change.

The City of Toronto will rehabilitate the Mill Street Bridge over West Don River. This work will ensure that the bridge meets today's standards and remains safe for vehicles and pedestrians into the future. The project is part of the Council-approved 2021 Capital Works Program.

### IMPORTANT INFORMATION ABOUT COVID-19 AND CONSTRUCTION WORK IN TORONTO

#### WORK DETAILS

The City's contractor will:

- Repair and refurbish the existing Mill Street Bridge over West Don River
- Reconstruct the railing with heritage style design and concrete parapet walls with a stone finish
- Reconstruct approach slabs
- Patch repair the concrete deck, girders and abutments
- Place a concrete overlay on the bridge deck
- Replace the sidewalks and bridge bearings
- Replace the asphalt surface and waterproofing
- Improve bridge approaches and drainage
- Repair concrete panels in the river channel
- Restoration of Disturbed Areas

### WHAT TO EXPECT DURING CONSTRUCTION

• You may experience dust, noise and other inconveniences. The City will make efforts to reduce impacts. We appreciate your patience.



**Work Hours**: Work will take place from 7 a.m.to 7 p.m., Monday to Friday, with work after hours and on weekends as required.

### **Construction Notice**

<b>오</b> 망 망 -	<ul> <li>Pre-Construction Inspection: All properties within 30 metres of the construction area will be surveyed before construction starts. The inspection will look at the interior and exterior of all properties to verify existing conditions. Although participation is voluntary, the City encourages all homeowners to participate. Without the survey, it will be difficult to confirm any claims of damage caused by construction.</li> <li>Affected properties will receive a separate notice to set up an appointment. All inspection staff will wear photo I.D. and carry photo equipment for this work.</li> </ul>
÷	<b>Road and Sidewalk Access:</b> In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the work zone. Access for emergency vehicles will be maintained at all times.
	Pedestrian passage will be maintained either on the North or South side of Mill Street.
8	<b>Traffic Management</b> : Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users.
	Traffic on Mill Street will be reduced to one lane for 2-way traffic. This will be facilitated using temporary traffic signals.
	<b>Physical Distancing:</b> There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility clothing and will maintain physical distancing.
	<b>Site Safety:</b> Workers on site are responsible for the work assigned to them. If you have construction questions or an issue on site – ask to be directed to the site inspector. If the site inspector is unavailable, contact the person listed at the end of this notice.
R	<b>Parking:</b> This project will affect on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.
	<ul> <li>Parking Violation Notice: If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, do the following within 15 days of the notice date:</li> <li>1) Contact the site inspector or person listed on the Construction Notice and give them the yellow notice number.</li> <li>2) Dispute the parking violation notice online or in person following the process listed on the back of the parking violation notice.</li> <li>You may use this construction notice as part of the explanation of why the violation should be cancelled. Please note: violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in no parking zones).</li> <li>In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction and may need to temporarily park on your street.</li> </ul>
Ŀ	<b>Accessible Accommodation:</b> Residents who require accommodation (level entry, longer notice, etc.) must contact the <b>Project Manager</b> to arrange for access during the construction period.

# **Construction Notice**



**Restoration:** The construction work area will be restored with sod, concrete and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).
