# **Scarborough Waterfront Combined Sewer Overflows Stormwater Outfall Control and Flood Protection Study Addendum**

## Municipal Class Environmental Assessment - Notice of Filing of Study Addendum

### The City of Toronto has completed a Municipal Class

Environmental Assessment (EA) study addendum to update the Scarborough Waterfront Combined Sewer Overflow (CSO) and Stormwater Outfall Control Study completed in 2011. The objective of the study addendum is to update the study considering significant differences in potential flooding and combined sewer overflow identified as part of a technical update completed in 2018. The study addendum identifies solutions to reduce the risk of future flooding, reduce combined sewer overflows and address receiving water quality while allowing renewed public and agency consultations.

Following consultation with Indigenous Groups, Review Agencies, City Divisions and the public, the following highlights the main changes to the study recommendations which were accepted by the City:

- More extensive sewer upgrades or realignment (total 28 km of primarily storm sewers)
- Install up to 6 km of new storm sewers •
- Smaller underground combined sewage storage tank at the south end of Warden Avenue to store excessive storm and combined sewage during heavy rain periods
- Eliminate several sewer system interconnections (between storm and combined sewer system)

## **Opportunities for review**

The study addendum was carried out following the requirements for Schedule C project under the Municipal Class EA. Please note that only the changes proposed in the Addendum are open for review. The Study Addendum Report has been placed on public record for a 30-day review period starting May 20, 2021 and ending June 19, 2021.
