TORONTO LICENSING TRIBUNAL ELECTRONIC HEARING: May 27, 2021 (1:00 PM) Summary of Decisions P. Turtle / A. Bakshi / M. Laverty

1. Dandx Health Centre Ltd. (Report No. 7584)

o/a Bliss Wellness Studio TO Dewei Cao, President Applicant for the Renewal of Holistic Centre Licence No. B30-4423904 AND Dewei Cao Applicant for the Renewal of Holistic Practitioner Licence No. T30-3957197

DECISION:

The Tribunal approved the joint Proposed Resolution signed on May 27, 2021, as follows:

"The business licences Licence No. B30-4423904 (a Holistic Centre Licence) and Licence No. T30-3947197 (a Holistic Practitioner Licence) will be renewed effective immediately (collectively, the "**Licences**"), subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the Licences may be cancelled;
- (2) The Licences will be suspended for a period of twenty-five (25) consecutive days, commencing on the first day Holistic Centres are permitted to open for business in Toronto, following the current Public Health closure;
- (3) The Licences will be placed on probation for an additional three (3) years until July 18, 2025. The Licensees are advised that during the probationary period, MLS may make additional checks of any criminal, and by-law charges and convictions against the Licensees and its director, and conduct other investigations, as appropriate, to assess the Licensees' compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;

- (4) Dandx Health Centre Ltd. and Mr. Cao will remove all advertisement, including but not limited to Bliss Wellness Studio TO websites/webpages, that suggest to the public that adult entertainment services are offered at Bliss Wellness Studio TO location or that might be interpreted as such, and will cease to publish, in any manner, an advertisement that suggest to the public that services other than holistic services permitted by Chapter 545 are being offered at Bliss Wellness Studio TO location;
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against the Licensees, their director, or any other concerns with respect to the conduct of the Licensees and their director, those matters and report no. 7584 and any updating material, may be brought back before the Tribunal for a full hearing."
