- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Any fines arising out of pending by-law charges against 2300943 Ontario Inc., as shown in Report No. 7648, shall be paid within the time provided by the court, failing which the licence shall be suspended until payment of the fines is made and MLS is satisfied with proof of same; and
- (3) Tong Jie Zhang shall not be permitted to enter the premises of 4801 Steeles Avenue West, Unit 3, Toronto, Ontario, nor shall she have any involvement whatsoever in the business operations of 2813142 Ontario Inc., operating as Vivid Spa, including but not limited to, as a shareholder, officer, director, manager, operator, attendant, employee or contractor, nor shall she have any legal, beneficial or other financial interest in the ownership of the business and/or the ongoing operations of the Licence or Vivid Spa;"
