1. Mohamad Hassan Zbib (Report No. 7581) Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4721230

DECISION:

The Tribunal ordered Mr. Zbib's Vehicle-For-Hire Driver's Licence No. D01-4721230 will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Upon being renewed, the Vehicle-For-Hire Driver's Licence will be placed on probation for a period of one (1) year. Mohamad Hassan Zbib is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Zbib and conduct other investigations, as appropriate, to assess Mr. Zbib's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Zbib or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7581 and any updating material, may be brought back before the Tribunal for a full hearing.

2. Troy Carl Jules Brammall (Report No. 7607) Applicant for a Tow Truck Driver's Licence (Application No. C100425)

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on May 1 and May 3, 2021, as follows:

"Tow Truck Driver's Licence will be issued, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Upon being issued, the Tow Truck Driver's Licence will be placed on probation for a period of THREE (3) years. Troy Carl Jules Brammall is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Brammall and conduct other investigations, as appropriate, to assess Mr. Brammall's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next THREE (3) renewals of the licence, Troy Carl Jules Brammall must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Troy Carl Jules Brammall or any other concerns with respect to the conduct of the licensee, those matters and report no. 7607 and any updating material, may be brought back before the Tribunal for a full hearing."
