## DECISION:

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"Taxicab Owner's Licence be renewed subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 6 months of the Tribunal hearing, failing which the licences may be cancelled;
- (2) The Taxicab Owner's Licence will be placed on probation until January 16, 2023. Ramesh Ajodha Seenath is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Ramesh Ajodha Seenath and conduct other investigations, as appropriate, to assess Ramesh Ajodha Seenath's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Ramesh Ajodha Seenath or any other concerns with respect to the conduct of the licensee, those matters and report no. 7255 and any updating material, may be brought back before the Tribunal for a full hearing."

**2. Joan Sebastian Bernal Trujillo** (Report No. 7455) Applicant for a Tow Truck Driver's Licence (Application No. C012526)

## DECISION:

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"Tow Truck Driver's Licence will be issued to Joan Sebastian Bernal Trujillo, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, the Tow Truck Driver's Licence will be placed on probation for a period of four (4) years. Joan Sebastian Bernal Trujillo is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Joan Sebastian Bernal Trujillo and conduct other investigations, as appropriate, to assess Joan Sebastian Bernal Trujillo's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next four (4) renewal(s) of the licence, Joan Sebastian Bernal Trujillo must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Joan Sebastian Bernal Trujillo or any other concerns with respect to the conduct of the licensee, those matters and report no. 7455 and any updating material, may be brought back before the Tribunal for a full hearing."
