1. Northern Smokes Inc. (Report No. 7589)

## **DECISION:**

The Tribunal approved the joint Proposed Resolution signed on June 10, 2021 on consent, as follows:

"Eating Establishment Licence will be issued, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Upon being issued the Eating Establishment Licence will be suspended for two (2) consecutive days, Monday, June 14<sup>th</sup> and Tuesday, June 15<sup>th</sup>, 2021;
- (3) The Eating Establishment Licence will be placed on probation for a period of three (3) years. Northern Smokes Inc. is advised that during the probationary period, MLS may make additional checks of any criminal and by-law charges and convictions against Northern Smokes Inc., Farzana Wali and Imran Dawood Ali, and conduct other investigations, as appropriate, to assess Northern Smokes Inc., Farzana Wali and Imran Dawood Ali's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (4) Prior to each of the next three (3) renewal(s) of the licence, Northern Smokes Inc. must provide to Municipal Licensing and Standards, at its own expense, an original up-to-date abstract of Imran Dawood Ali's Criminal Record and Judicial Matters Check;

(5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Northern Smokes Inc., Farzana Wali, Imran Dawood Ali or any other concerns with respect to the conduct of the licensee, those matters and report no. 7589 and any updating material, may be brought back before the Tribunal for a full hearing."
