### Sanitary, Storm Sewers and Maintenance Hole Rehabilitation Works South of Front Street from Rees Street to Lower Sherbourne Street

Contract: 21ECS-MI-01SA

Start Date: Late-July, 2021 End Date: November 2021

\*Timeline is subject to change.

The City of Toronto will rehabilitate the sanitary and storm sewers and maintenance holes at the following locations as part of the Wet Weather Flow Reduction in the Scott Street Pumping Station Service area (see map and work details below).

- Site 1: George Street South, from Henry Lane Terrace to Wilton Street
- Site 2: Market Street, at the end of Wilton Street
- Site 3: Lake Shore Boulevard East, from Cooper Street to Freeland Street
- Site 4: Lake Shore Boulevard East, from Cooper Street to Lower Jarvis Street.
- Site 6: Freeland Street, from Lake Shore Boulevard East to Queens Quay East
- Site 7: Freeland Street, from Lake Shore Boulevard East to Queens Quay East
- Site 8: Harbour Street, from York Street to Bay Street
- Site 9: Harbour Street, from York Street to Bay Street
- Site 10: Harbour Street, from York Street to Bay Street
- Site 12: Harbour Street, at Bay Street
- Site 13: Harbour Street, from Bay Street to Yonge Street
- Site 14: Lake Shore Boulevard West, from Rees Street to Lower Simcoe Street
- Site 15: Lake Shore Boulevard West, from Rees Street to Lower Simcoe Street
- Site 16: Lake Shore Boulevard West, from Rees Street to Lower Simcoe Street
- Site 17: Lake Shore Boulevard West, from Rees Street to Lower Simcoe Street
- Site 18: Queens Quay West, from York Street to Bay Street
- Site 19: Freeland Street, from Lake Shore Boulevard East to Queens Quay East
- Site 20: Scadding Avenue, from Lower Sherbourne Street to Princess Street
- Site 21: Lakeshore Boulevard East, from Cooper Street to Freeland Street
- Site 22: Lower Sherbourne Street, from Lake Shore Boulevard East to Queens Quay East

In order to address sewer capacity concerns and reduce the stormwater inflow to the sanitary system, the City conducted an inflow and infiltration study in the project area and this rehabilitation work is designed to help address those concerns. This project is part of the Council-approved 2021 Capital Works Program that will improve the sanitary system and the City's aging infrastructure.

#### IMPORTANT INFORMATION ABOUT COVID-19 AND CONSTRUCTION WORK IN TORONTO



Note: Sites 5 and 11 are not included in the scope of this contract.


#### Work on all sites will include:

- Support and protection of existing utilities, and flow management/sewer bypass pumping;
- Temporary sidewalk and/or lane closures, and traffic management; and
- Restoration and resurfacing the road on all areas affected by construction.

#### WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property.



**Work Hours**: Work will take place Monday to Friday. Weekend or overnight work will be subject to the approval of Work Zone Coordinator.

Note: Much of the work is anticipated to be complete overnight in order to minimize disruption within the roadway. Your patience and understanding is appreciated.



**Site Safety:** Workers on site are responsible for the work assigned to them. If you have construction questions or an issue on site – ask to be directed to the site inspector. If the site inspector is unavailable, contact the person listed at the end of this notice.



**Physical Distancing:** There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility clothing. If you have questions, call the contact provided on this notice.



**Site Access:** In order to complete the work in a safe manner, there may be road and crosswalk restrictions within the construction work zone. Access for emergency vehicles will always be maintained.



**Traffic Management**: Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Road users should expect delays and increased traffic on nearby main and side streets.





Parking: Parking in the active work zone is not permitted as space is needed for construction equipment and materials. This project will affect on-street parking. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call **416-808-2222** for its location.



**Parking Violation Notice:** In an effort to reduce ticketing due to construction, the City encourages communities with construction to be patient as neighbours may need to temporarily relocate vehicles. If enforcement is called, enforcement must issue a yellow parking violation notice (ticket). If you receive a yellow notice during this construction work, do the following within 15 days of the notice date:

- 1) Contact the site inspector or person listed on the Construction Notice and give them the yellow notice number.
- 2) Dispute the parking violation notice online or in person following the process listed on the reverse side of the parking violation notice.

You may use this construction notice as part of the explanation of why the violation should be cancelled. Please note: violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in no parking zones).



Restoration: All areas affected by construction will be restored.
