## **DECISION:**

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"The business licences Licence No's. V10-5000339, V10-50005955, V10-5012789, V10-4970923, V10-4973791, V10-4974483, V10-4976188, V10-4980751 and V10-4980752 (Tow Truck Owner Licences) and Licence No. D09-4970930 (a Tow Truck Driver Licence) will be renewed effective immediately (collectively, the "Licences"), subject to the following conditions:

(1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the Licences may be cancelled: July 15, 2021

- (2) Effective July 15<sup>th</sup>, 2021, the Licences will be placed on probation for a period of FIVE (5) years. The Licensees are advised that during the probationary period, MLS may make additional checks of any criminal, driving, and by-law charges and convictions against the Licensees and its director, and conduct other investigations, as appropriate, to assess the Licensees' compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next FIVE (5) renewal(s) of the licences, Rami Abu-Amireh must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against the Licensees, their director, or any other concerns with respect to the conduct of the Licensees and their director, those matters and report no. 7594 and any updating material, may be brought back before the Tribunal for a full hearing."
