





Built Form Study Update

- Midtown in Focus: Detailed built form analysis conducted as part of the initial stage of work
- Current study undertaken to reflect the Provincial modifications to OPA 405 and in-force Yonge-Eglinton Secondary Plan (YESP)
- Study Focus:
 - Updating 3D massing model
 - Micro-climate analysis (wind, shadow)
 - Tall building step-backs, tower separation, and built form transition
 - Height Analysis interpreting height guidance with other relevant policies
 - Updated development yields
- Study to incorporate findings from Broadway & Erskine Block Study


Parks Update





New Parks and Improvement Projects

- Rolling implementation of the Midtown Parks and Public Realm Plan has included the acquisition of new parkland and improvement of existing parks.
- Master Plan completed for Eglinton Park
- Ongoing acquisition includes conversion of Castlefield/Duplex TPA lot to parkland





Park Districts

Staff have identified Park Districts to guide parks planning in Midtown and identify priorities.

Each District consists of a local network of parks, streets and other open spaces centered on one or more

significant "anchor" parks.

 Criteria applied to identify priority Park Districts:

- Park Districts prioritized for acquisition include Mount Pleasant and Eglinton, and June Rowlands Park Districts.
- Park Districts prioritized for improvements include Mount Pleasant and Eglinton, June Rowlands, and Howard Talbot Park Districts.





Parks - Next Steps


Revitalization of Redpath Avenue Parkette

- Identified as a priority for improvements.
- Located in Mount Pleasant and Eglinton Park District, which scored highly on prioritization criteria.
- Next steps for consultation are being discussed with Councillor's Office.



Public consultation for potential park improvements in Midtown

- Social Pinpoint exercise (summer 2021)
- Follow-up PPR consultation (fall 2021)
