TORONTO LICENSING TRIBUNAL ELECTRONIC HEARING: July 8, 2021 (1:00 PM) Summary of Decisions V. Francis / M. Laverty / M. Lee

1. Latest GEN Automotive Inc. (Report No. 7586)

o/a The Six Towing Nakul Vikneswaran, President Holder of Tow Truck Owner's Licence No. V10-4827055, Plate No. 5932 AND Holder of Public Garage Licence No. B68-4878954 AND Nakul Vikneswaran Applicant for the Renewal of Tow Truck Driver's Licence No. D09-4305009

DECISION:

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"The business licences Licence No. V10-4827055 (a Tow Truck Owner Licence), Licence No. B68-4878954 (a Public Garage Licence) and Licence No. D09-4305009 (a Tow Truck Driver Licence) will be renewed effective immediately (collectively, the "**Licences**"), subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the Licences may be cancelled;
- (2) The Licences will be placed on probation for a period of FOUR (4) years. The Licensees are advised that during the probationary period, MLS may make additional checks of any criminal, and by-law charges and convictions against the Licensees and its director, and conduct other investigations, as appropriate, to assess the Licensees' compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next FOUR (4) renewal(s) of the licences, Nakul Vikneswaran must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;

- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against the Licensees, their director, or any other concerns with respect to the conduct of the Licensees and their director, those matters and report no. 7586 and any updating material, may be brought back before the Tribunal for a full hearing."

- 2. Raid Toma Tobia (Report No. 7604)

Applicant for a Tow Truck Driver's Licence (Application No. C043860)

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on July 8, 2021, as follows:

"Tow Truck Driver's Licence will be issued, subject to the following conditions:

- All fees, documents and/or any outstanding requirements, must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Upon being issued, the Tow Truck Driver's Licence will be placed on probation for a period of THREE (3) years. Raid Toma Tobia is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Raid Toma Tobia and conduct other investigations, as appropriate, to assess Raid Toma Tobia's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next THREE (3) renewal(s) of the licence, Raid Toma Tobia must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Raid Toma Tobia or any other concerns with respect to the conduct of the licensee, those matters and report no. 7604 and any updating material, may be brought back before the Tribunal for a full hearing."
