Humber Creek Restoration West of Scarlett Road

Contract: 21ECS-LU-02SM

Expected Start Date: August 30, 2021 Expected End Date: December 31, 2021

The City of Toronto is planning to restore a section of Humber Creek upstream of Scarlett Road that has been damaged due to creek erosion. This creek erosion has resulted in the exposure of a sanitary sewer and damage to a storm sewer outfall. The work area is located behind properties on Saxony Crescent and Chapman Road as shown on the map below.

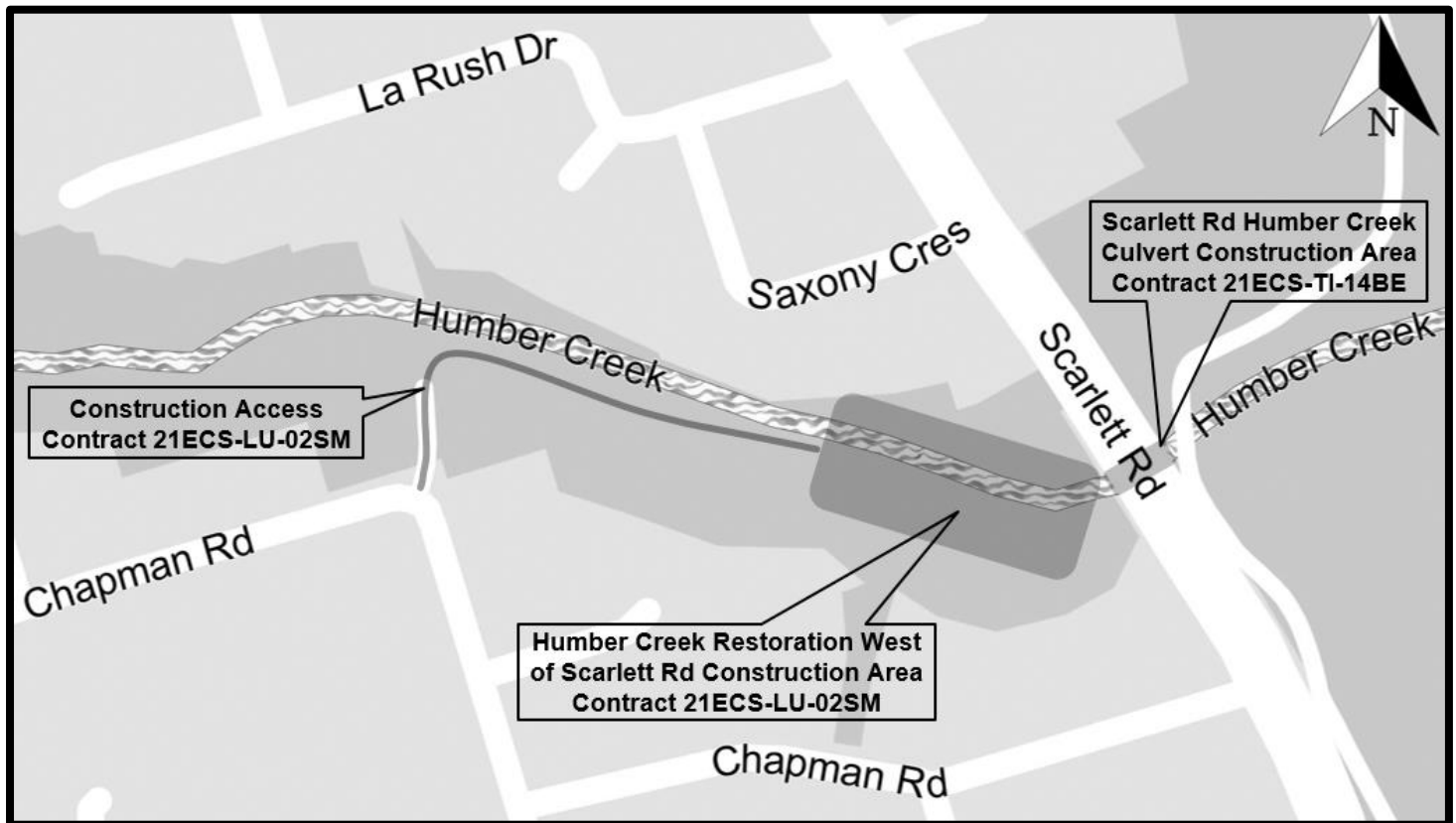
The creek restoration will provide erosion protection to the exposed sanitary sewer by installing armourstone and a new concrete encasement around the sewer. The work will also consist of installing a new storm sewer outfall.

The project is part of the Council-approved 2021 Capital Works Program. This work will occur within the same timeframe as the replacement of the culvert under Scarlett Road at Humber Creek under Contract 21ECS-TI-14BE. Both projects will proceed in a coordinated manner.

MAP OF WORK AREA










WORK DETAILS

The City's contractor will:

- use an existing construction access to the work area off of Chapman Road as shown on the map;
- manage traffic at the construction access entrance off of Chapman Road to ensure construction equipment enters and exits safely with minimal traffic disruptions;
- work within Humber Creek and the valley lands to protect and restore Toronto Water infrastructure and the creek; and
- restrict access to Chapman Valley Park from Chapman Road and Scarlett Road to allow for construction and staging areas.

WHAT TO EXPECT DURING CONSTRUCTION

You may experience dust, noise and other inconveniences. The City will make efforts to reduce impacts. We appreciate your patience.

|  | <p>Tree Removal: Due to the nature of this project, the City will have to remove trees from public property along Humber Creek. A tree removal permit has been obtained in coordination with the City's Parks, Recreation & Forestry Division. Trees removed for the project will be replaced following construction.</p> |
|  | <p>Work Hours: Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.</p> |
|  | <p>Site Safety: Workers on site are responsible for the work assigned to them. If you have construction questions or an issue on site – ask to be directed to the site inspector. If the site inspector is unavailable, contact the person listed at the end of this notice.</p> |
|  | <p>Physical Distancing: There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility clothing and will maintain physical distancing.</p> |
|  | <p>Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the work zone. Access for emergency vehicles will be maintained at all times.</p> |
|  | <p>Traffic Management: Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. During construction, there will be minor delays and increased traffic on Chapman Road and Saxony Crescent.</p> |
|  | <p>Restoration: The construction work area will be restored with seeding and/or sod, concrete and/or asphalt where required to its initial condition. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).</p> |
