1. 2161217 Ontario Ltd. (Report No. 7655)

o/a Guarantee Towing Antonio Figliomeni, President Applicant for a Tow Truck Owner's Licence (Application No. C101691)

DECISION:

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"Tow Truck Owner's Licence will be issued, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Upon being issued the Tow Truck Owner's Licence will be placed on probation for a period of two (2) years. Antonio Figliomeni is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against 2161217 Ontario Ltd. and Antonio Figliomeni and conduct other investigations, as appropriate, to assess the compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against 2161217 Ontario Ltd. and Antonio Figliomeni or any other concerns with respect to the conduct of the licensee, those matters and report no. 7655 and any updating material, may be brought back before the Tribunal for a full hearing."

Applicant for a Tow Truck Owner's Licence (Application No. C112592)

DECISION:

The Tribunal approved the joint Proposed Resolution signed on September 9, 2021, as follows:

"Tow Truck Driver's Licence and Tow Truck Owner's Licence will be issued, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) The Tow Truck Driver's Licence and Tow Truck Owner's Licence will be placed on probation for a period of four (4) years. Michael Justin Mills is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Michael Justin Mills and conduct other investigations, as appropriate, to assess Michael Justin Mills' compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next four (4) renewal(s) of the licence, Michael Justin Mills must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Michael Justin Mills or any other concerns with respect to the conduct of the licensee, those matters and report no. 7654 and any updating material, may be brought back before the Tribunal for a full hearing."
