3. Homayon Najafi (Report No. 7549) Holder of Taxicab Owner's Licence No. V02-3616423, Plate No. 3422

DECISION:

The Tribunal approved the withdrawal of Report No. 7549 by Municipal Licensing and Standards.

4. Arsilan Esteban Al Piacentini (Report No. 7599) Applicant for the Renewal of Tow Truck Driver's Licence No. D09-4959095

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on August 24, 2021, as follows:

"Tow Truck Driver's Licence will be issued, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) The Tow Truck Driver's Licence will be placed on probation for a period of one (1) year. Arsilan Esteban Al Piacentini is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Arsilan Esteban Al Piacentini and conduct other investigations, as appropriate, to assess Arsilan Esteban Al Piacentini's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Arsilan Esteban Al Piacentini or any other concerns with respect to the conduct of the licensee, those matters and report no 7599 and any updating material, may be brought back before the Tribunal for a full hearing."

5. De Vaughn Alex Joseph-Watson (Report No. 7619) Applicant for the Renewal of Tow Truck Driver's Licence No. D09-4805517

DECISION:

The Tribunal approved the Proposed Resolution, on consent, as follows:

"Tow Truck Driver's Licence will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Upon being renewed, the Tow Truck Driver's Licence will be placed on probation for a period of four (4) years. De Vaughn Alex Joseph-Watson is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against De Vaughn Alex Joseph-Watson and conduct other investigations, as appropriate, to assess De Vaughn Alex Joseph-Watson's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against De Vaughn Alex Joseph-Watson or any other concerns with respect to the conduct of the licensee, those matters and report no. 7619 and any updating material, may be brought back before the Tribunal for a full hearing."
