1. Ephrem Belay Berhane (Report No. 7658) Holder of Vehicle-For-Hire Driver's Licence No. D01-2019928

DECISION:

The Tribunal approved the request for adjournment of this matter to November 18, 2021 at 1:00 p.m., on consent.

 Theofilos Georgalis (Report No. 7660) Applicant for the Renewal of Motorized Refreshment Vehicle Owner's Licence Nos: V15-3107115 and V15-3243939; Plate Nos. 110 and 49

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on September 15, 2021, as follows:

"Motorized Refreshment Vehicle Owner's Licences will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licences may be cancelled;
- (2) The Motorized Refreshment Vehicle Owner's Licences will be placed on probation for a period of two (2) years. Theofilos Georgalis is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Theofilos Georgalis and conduct other investigations, as appropriate, to assess Theofilos Georgalis' compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;

(3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Theofilos Georgalis or any other concerns with respect to the conduct of the licensee, those matters and report no. 7660 and any updating material, may be brought back before the Tribunal for a full hearing."

3. Saeidreza Vasheghani (Report No. 7646)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4757506

DECISION:

The Tribunal approved the joint Proposed Resolution signed September 16, 2021, as follows:

"Vehicle-For-Hire Driver's Licence be renewed subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licences may be cancelled;
- (2) The Vehicle-For-Hire Driver's Licence will be placed on probation for a period of Two (2) years. Saeidreza Vasheghani is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Saeidreza Vasheghani and conduct other investigations, as appropriate, to assess Saeidreza Vasheghani's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Saeidreza Vasheghani or any other concerns with respect to the conduct of the licensee, those matters and report no. 7646 and any updating material, may be brought back before the Tribunal for a full hearing."
