Road Reconstruction on Kingston Road from Deep Dene Drive to Centennial Road

Contract: 21ECS-TI-01MR Start Date: August 2021 End Date: June 2022 *Timeline is subject to change.

The City of Toronto is planning to reconstruct the road and replace the City-owned portion of substandard water services on Kingston Road from Deep Dene Drive to Centennial Road. Our inspection of the road shows that it needs reconstruction, and the curb and sidewalk need to be replaced to bring them to a state of good repair.

The water service is the underground pipe that brings water to your water meter and is owned by you <u>and</u> by the City. The part you own is from your house to the end of your property, the part the City owns is from the end of your property to the watermain.

This project is part of the Council-approved 2021 Capital Works Program to renew aging city roads and sidewalk for current and future needs.


IMPORTANT INFORMATION ABOUT COVID-19 AND CONSTRUCTION WORK IN TORONTO

IMPORTANT INFORMATION ABOUT LEAD WATER SERVICES

If you live on Kingston Road in the area described above in a house that was built before the mid-1950s, your water service may be made of lead. Please read the attached fact sheet with important information about the risks of lead in drinking water, especially if someone in your house is pregnant, there are children under six years old, or there is an infant drinking formula made using tap water.

WHAT TO EXPECT BEFORE CONSTRUCTION

- Work crews will mark sidewalks and curbs requiring replacement and the locations of underground utilities, such as gas, water and cable so that the construction work does not interfere with these utilities.
- Affected properties will receive a Construction Notice approximately two weeks before work begins with more information about the work.
- The City will not be responsible for damage to any privately owned items on City property.

Ŀ	Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the Project Manager listed below.

Affected properties will receive a request to schedule a time to complete the pre- construction condition survey. Although participation is voluntary, the pre- construction survey results may be useful to confirm claims for potential damage caused by City construction.
	Traffic Management:
8	During construction westbound traffic will be maintained on Kingston Road. Eastbound traffic will be diverted through Morrish Road, Ellesmere Road or Meadowvale Road depending on the phase of work. More details will be provided in the Construction Notice.
B	Important information for owners of sprinkler systems / heated driveways and private landscaping features. Property owners should remove items located within City property limits (boulevard) to avoid damage.
<u>aa aa</u> aa aa	This includes items such as landscaping (plants and pavers), decorative objects, sprinkler systems or heated driveways. If you have a sprinkler system or heated driveway, please contact the Project Manager listed below.
	Substandard Water Service Replacement: Please take the time to read the attached fact sheet carefully as it contains important information on lead in drinking water and how to prepare for replacement. First, you need to find out if your water service is lead – a licensed plumber can help you with this. If it is lead, the City of Toronto encourages you to replace it. We recommend you obtain several quotes. PLEASE NOTE: The City is not able to get involved in any contract to have work done on private property. Property owners are responsible for ensuring contractors do not interfere with the work being done on City property. Learn more at www.toronto.ca/leadpipes
