## TORONTO LICENSING TRIBUNAL ELECTRONIC HEARING: September 30, 2021 (1:00 PM) Summary of Decisions A. Bakshi / M. Laverty / E. Montigny

**1. Omar Tarin** (Report No. 7428) Holder of Tow Truck Driver's Licence No. D09-4913182

## **DECISION:**

The Tribunal approved the joint Proposed Resolution signed on September 30, 2021 as follows:

"The Licence will continue, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of MLS within 30 days of the Tribunal hearing, failing which the Licence may be cancelled;
- (2) The Licence will be suspended for three (3) consecutive days commencing on Friday October 1<sup>st</sup>, 2021;
- (3) The Licence will be placed on probation for a period of one (1) year. The Licensee is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against the Licensee and conduct other investigations, as appropriate, to assess the Licensee's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if MLS has concerns with any new charges or convictions against the Licensee or any other concerns with respect to the conduct of the Licensee, those matters and report no. 7428 and any updating material, may be brought back before the Tribunal for a full hearing."

**2.** E D M Construction (Electrical Design and Maintenance) Ltd (Report No. 7622) Travis Jackson, Director

Applicant for a Building Renovator Licence (Application No. C100442)

## **DECISION:**

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"Building Renovator Licence will be issued, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Upon being issued the Building Renovator Licence will be placed on probation for a period of three (3) years. Travis Gladstone Jackson is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against E D M Construction (Electrical Design and Maintenance) Ltd. and Travis Gladstone Jackson and conduct other investigations, as appropriate, to assess the compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next three (3) renewal(s) of the licence, Travis Gladstone Jackson must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against E D M Construction (Electrical Design and Maintenance) Ltd. and Travis Gladstone Jackson or any other concerns with respect to the conduct of the licensee, those matters and report no. 7622 and any updating material, may be brought back before the Tribunal for a full hearing."
