This notice provides an update on rehabilitation of the Innes Avenue pedestrian bridge over the Metrolinx track.

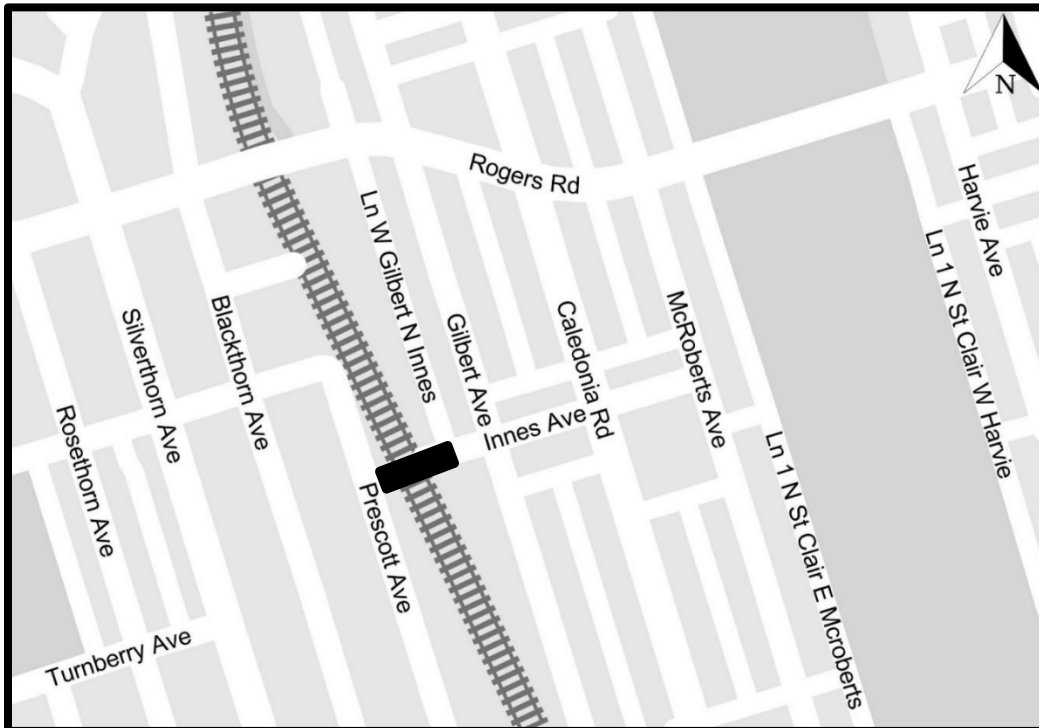
The project start and end dates have been revised due to the delay in execution of the contract agreement by the Contractor and their availability to initiate work on site.

We know this project has an impact to all residents along Innes Ave between Gilbert Ave and Prescott Ave. We sympathize and appreciate your patience with the dust, noise, fencing and other inconveniences.

MAP OF WORK AREA










WORK DETAILS

The City's contractor will:

- Patch repair the concrete deck and soffit
- Repair corroded structural steel sections at columns, beams, and truss members
- Clean and re-coat structural steel
- Install frames and enclosure mesh around the bridge ramps
- Extend roof over top level of the ramps
- Install new handrail

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce impacts. We appreciate your patience.

	<p>Work Hours: Work will take place from 7 a.m. to 11 p.m., Monday to Friday, and from 7 a.m. to 7 p.m. on weekends, except Statutory Holidays.</p> <p>Additionally, due to Metrolinx occupancy restrictions and daytime train schedule, there will be a period of approximately two months where the work will need to be completed overnight during Metrolinx's non-service window. Tentative overnight work hours are from 1 a.m. to 6 a.m., Monday to Friday, and from 12 a.m. to 10 a.m. on weekends.</p> <p>Information about overnight work will be provided in a future email update once construction progresses. 	<p>Pedestrian Access: In order to complete the work in a safe manner, the bridge will remain closed to pedestrians for the duration of construction. Pedestrians will have to take detour to cross the Metrolinx tracks either through Rogers Road or St. Clair Avenue West.</p> <p>Pedestrian detour signage will be posted.</p>
	<p>Traffic Management: Road users should expect delays and increased traffic on nearby main and side streets. When driving, please be mindful of vulnerable road users.</p>
	<p>Physical Distancing: There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility clothing and will maintain physical distancing.</p>
	<p>Site Safety: Workers on site are responsible for the work assigned to them. If you have construction questions or an issue on site – ask to be directed to the site inspector. If the site inspector is unavailable, contact the person listed at the end of this notice.</p>
	<p>Accessible Accommodation: Residents who require accommodation (level entry, longer notice, etc.) must contact the Field Ambassador to arrange for access during the construction period.</p>
	<p>Restoration: The construction work area will be restored with sod, concrete and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced.</p>
