
### Why Study Liberty Village?

• Significant population growth and ongoing development activity


- City Council directed staff to undertake study in July 2020 to:





- inform and identify opportunities for new parks, open spaces and public realm improvements as well as community service and facilities that can be secured through funding or space within future developments; and
- provide direction and a strategic, coordinated approach for the City-owned assets in Liberty Village to better meet the needs of the area

#### Allan A. Lamport Stadium Park at 1155 King St W




The park size is equivalent to 4 city blocks (approximately 200 metres x 200 metres).
