## Watermain Replacement on Attwell Drive from Marmac Drive to 80 Meters North of Fanboro Road

**Contract: 21ECS-LU-02SU**  
**Start Date: October 12, 2021**  
**Expected End Date: December 2021**  
**Revised End Date: January 31, 2022**  
*\*Timeline is subject to change.*

This notice provides an update on the City of Toronto's watermain replacement project on Attwell Drive from Marmac Drive to 80 meters north of Fanboro Road.

Due to unforeseen delays, underground construction work on Attwell Drive from Marmac Drive to 80 meters north of Fanboro Road is expected to be complete on January 31, 2022. Once weather conditions are favourable, the contractor will return in spring 2022 to permanently restore the curb, sidewalk, sod and roadway.

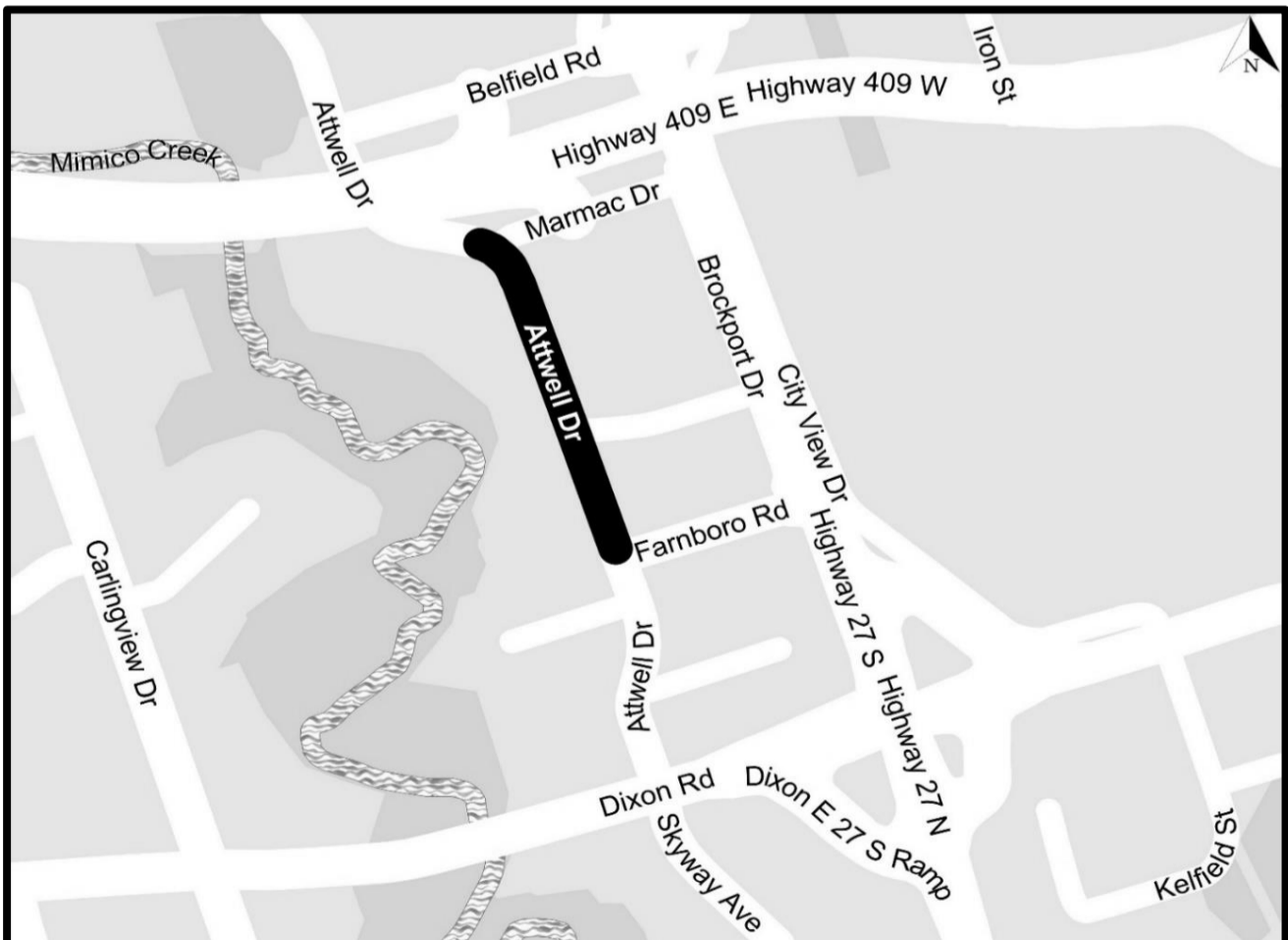
Prior to leaving the site on January 31, 2022, the contractor will temporarily restore sidewalks, curbs, and the roadway with temporary asphalt, and temporarily restore lawn areas with soil. A construction update notice will be issued before work resumes in spring 2022.

We know this project has an impact to residents and businesses along Attwell Drive. We sympathize and appreciate your patience with the dust, noise, fencing and other inconveniences.

## WORK STATUS TO-DATE

The contractor has:

- installed the new watermain;
- completed few street connections; and
- temporarily restored areas affected by watermain installation for the holiday season.







## REMAINING WORK



The contractor will:

- replace any water service pipes that did not meet City standards from the watermain to the private property line;
- complete remaining street connection;
- temporarily restore areas affected by watermain installation; and
- permanently restore areas affected by the watermain/water service installation.

## WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property.

	<p><b>Work Hours:</b> Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.</p>
	<p><b>Traffic Management:</b> Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Efforts have been made to manage traffic in the area for the safety of workers, road users and residents.</p> <p><b>Traffic on Attwell Drive may be reduced to one lane.</b></p>
	<p><b>Physical Distancing:</b> There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility clothing and will maintain physical distancing.</p>
	<p><b>Road and Sidewalk Access:</b> In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.</p> <p><b>Driveway Access:</b> The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.</p>
	<p><b>Pedestrians:</b> The work may require temporary sidewalk restrictions, however any necessary sidewalk closures will alternate in each direction to ensure pedestrian access is maintained during construction.</p>
	<p><b>Parking:</b> This project will affect on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.</p>

	<p><b>Parking Violation Notice:</b> If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, do the following within 15 days of the notice date:</p> <ol style="list-style-type: none"> <li>1) Contact the site inspector or person listed on the Construction Notice and give them the yellow notice number.</li> <li>2) Dispute the parking violation notice online or in person following the process listed on the back of the parking violation notice.</li> </ol> <p><b>You may use this construction notice as part of the explanation of why the violation should be cancelled. Please note:</b> violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in no parking zones).</p> <p>In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction and may need to temporarily park on your street.</p>
	<p><b>Accessible Accommodation:</b> The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.</p>
