Watermain Replacement and Road Upgrades on Jarvis Street from Dundas Street East to Bloor Street East

Contract: 21ECS-TI-01SP

Start Date: Week of June 21, 2021 End Date: November 2022

*Timeline is subject to change

As watermain replacement work continues on Jarvis Street, our contractor has begun working on the east side of Jarvis Street. During this phase, our contractor will continue service connections to properties on the west side of Jarvis Street. Service connections on the west side of the street will be done in phases. Our contractor will communicate with properties that require service connections and will determine the best time to have this work completed. Some of these service connections can take place overnight.

As mentioned in the last update, short term intermittent road and lane closures will take place on several local streets adjacent to Jarvis Street during watermain installation until August 30th. These closures are dependent upon the daily progress of work and are difficult to schedule exact dates and times. Please see listing of local streets below that temporary lane/road closures are anticipated for. During this work our contractor will have Paid Duty Officers on site to monitor and direct traffic.

IMPORTANT INFORMATION ABOUT COVID-19 AND CONSTRUCTION WORK IN TORONTO

INTERMITTENT TEMPORARY LANE/ROAD CLOSURES ON LOCAL ROADS July 26 – August 30th



During watermain installation our contractor will have to close some sections of roads in the Jarvis Street area for short periods of time during excavation and service connections. These temporary closures will last approximately 4 - 6 hours due to specific work being completed adjacent to the Jarvis Street watermain.

Temporary closures will take place on the following streets: Charles Street, Isabella Street, Maitland Street, Gloucester Street, Earl's Place, and Cawthra Square. During these temporary closures the contractor will have traffic control personnel on site to monitor and direct traffic during the closure. The contractor will allow access for residents during the closure when possible.

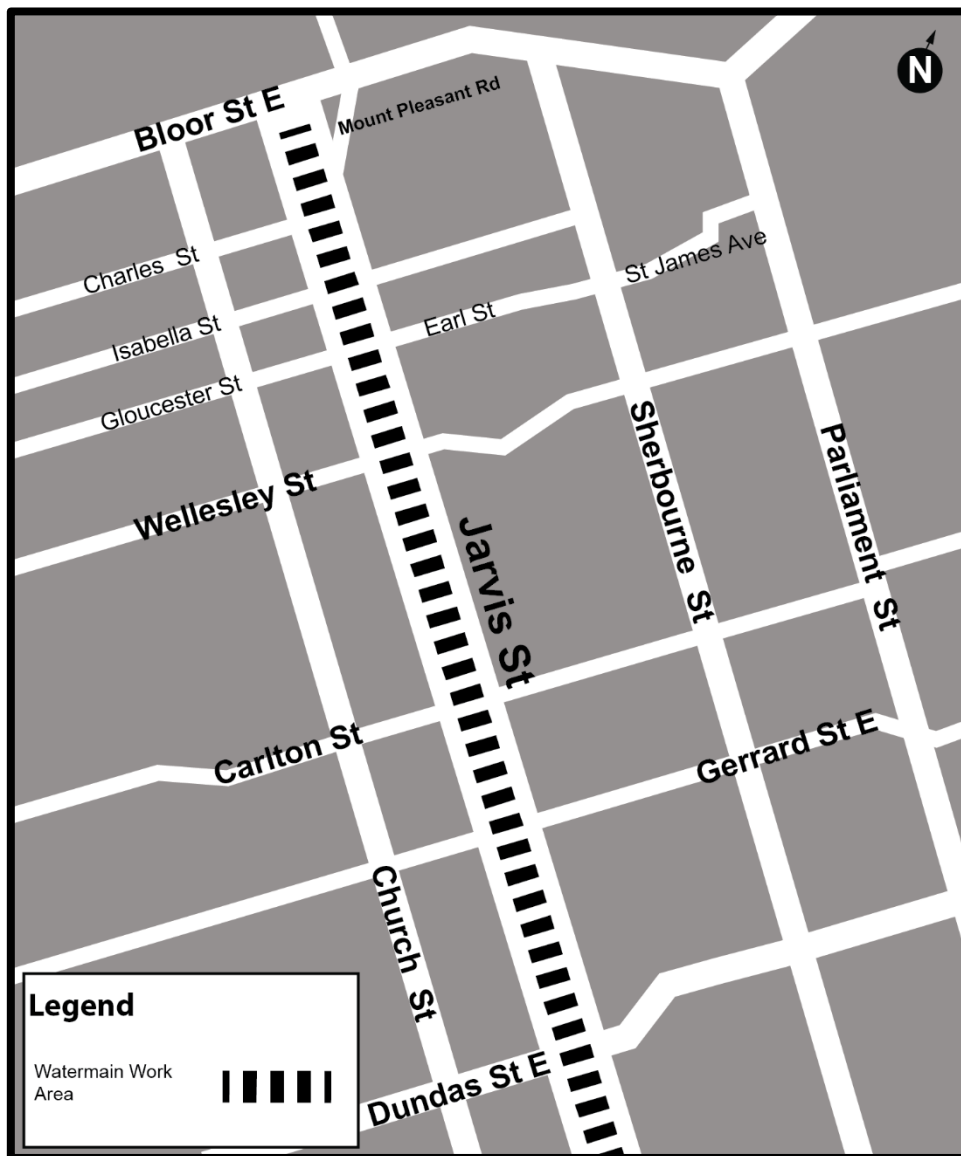
WHAT TO EXPECT DURING CONSTRUCTION

You will experience dust, noise and other inconveniences. The City will make efforts to reduce local impacts. Your patience is appreciated.

	<p>Work Hours: Work will take place from 7 a.m. to 11 p.m., Monday to Friday and from 9 a.m. to 5 p.m. on Saturdays or Sundays as required.</p>
	<p>Traffic Management: Road users should expect delays and increased traffic on nearby streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users.</p> <ul style="list-style-type: none"> • Traffic on Jarvis street will be reduced to one lane in each direction

	<p>Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.</p>
	<p>Driveway Access: During temporary lane/road closures on local roads the contractor will notify residents of any temporary restrictions to your driveway access. Access for emergency vehicles will be maintained at all times.</p>
	<p>Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the Public Consultation Unit staff listed below.</p>
