### 34.7 – DECISION TIMELINES AND MEMBER ACCOUNTABILITY

The Toronto Local Appeal Body Chair to review the issue of Decision Timelines and Member accountability

#### **Summary**

Members have generally supported the rationale that timely decision reporting is not just a service to the public as expected of the TLAB by City Council, but also serves to avoid the potential for 'backlog building' that can overwhelm and compromise the Member as well as the Tribunal.

In 2019, the TLAB adopted a revised voluntary decision turnaround timeline of '14 business days' for the issuance of a Member's decision and order. To reflect a more realistic turnaround timeline that is reflective of current circumstances impacting TLAB operations and Tribunal Members, the Chair is proposing that the timeline be modified.

#### Motion:

"THAT the Toronto Local Appeal Body's established voluntary 'turnaround' timeline of 14 business days for the issuance of a Members' decision and order following the completion of the appeal hearing event be amended to a turnaround time of <u>21 business days</u>, as of January 1, 2022"
