This notice provides an update on storm sewer relining on Morningside Avenue from Military Trail to Ellesmere Road.

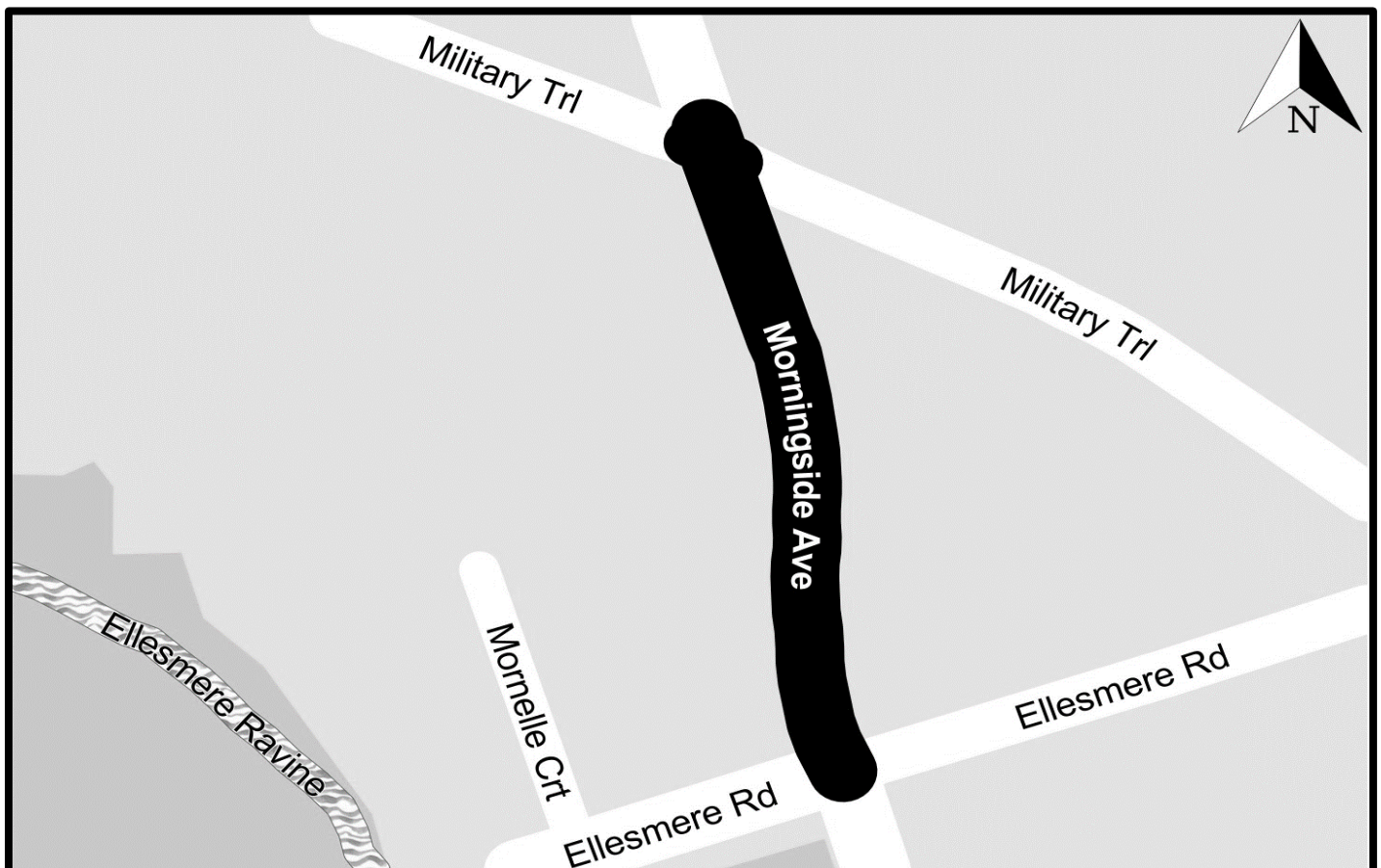
Work on this project is currently behind schedule. This delay was caused by an industry wide material shortage. The sewer relining work on site was previously suspended and will resume on January 24, 2022. Following the completion of the sewer relining work, the work on site will again be suspended until Spring 2022 when permanent restoration will be completed during favourable weather conditions.

We know this project has an impact to all businesses and residents along Morningside Avenue from Military Trail to Ellesmere Road. We sympathize and appreciate your patience with the dust, noise, fencing and other inconveniences.

The contractor has completed the following work:

- Cleaned and prepared the inside of sewer pipe
- Excavated the boulevard for access to sewer pipe
- Relined some sewer pipe sections along Morningside Avenue.









## REMAINING WORK

The contractor will perform the following work:

- Install sewer bypass system
- Reline the remaining sewer pipe in sections; and
- Restore disturbed areas

## WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property.

	<p><b>Work Hours:</b> Work will take place from 7 a.m. to 9 p.m., Monday to Friday, with work after hours and on weekends as required.</p>
	<p><b>Traffic Management:</b> Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Efforts have been made to manage traffic in the area for the safety of workers, road users and residents.  <b>Southbound traffic on Morningside Avenue will be reduced to one lane.</b></p>
	<p><b>Physical Distancing:</b> There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility clothing and will maintain physical distancing.</p>
	<p><b>Road and Sidewalk Access:</b> In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.  <b>Driveway Access:</b> The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.</p>
	<p><b>Pedestrians:</b> The work may require temporary sidewalk restrictions, however any necessary sidewalk closures will alternate in each direction to ensure pedestrian access is maintained during construction.</p>
	<p><b>Cyclists:</b> If travelling Southbound on Morningside Avenue, please share the traffic lane in the active work zones</p>
	<p><b>Parking:</b> This project will affect on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.</p>
	<p><b>Parking Violation Notice:</b> If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, do the following within 15 days of the notice date:</p> <ol style="list-style-type: none"> <li>1) Contact the site inspector or person listed on the Construction Notice and give them the yellow notice number.</li> <li>2) Dispute the parking violation notice online or in person following the process listed on the back of the parking violation notice.</li> </ol> <p><b>You may use this construction notice as part of the explanation of why the violation should be cancelled. Please note:</b> violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in no parking zones).          In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction and may need to temporarily park on your street.</p>



**Accessible Accommodation:** The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.
