



Major Provisions

Licensee:	Metrolinx
Licensed Area:	Approximately 175.9 square meters
Licence Fee:	\$2.00, being a nominal amount. The License Fee does not include utilities or costs incurred by the City.
Term:	Three (3) months, commencing on the date of TRCA's Voluntary Project Review letter or the date of the agreement if Metrolinx has already obtained TRCA's Voluntary Project Review letter prior to execution of the agreement.
Use:	Access and property grading
Early Termination Right.	Metrolinx shall have the right to terminate the licence during the term upon providing the City with 30 days' written notice
Existing Right Holders:	The Agreement is subject to all leases, subleases, easements, licences, permits, rights of use or occupation or other rights of Existing Rights Holders (as defined in the Agreement)
