It was further extended through September 30, 2021, authorized by 200, again further extended through December 31, 2021, authorized by DAF 2021-274, and extended agar rooms 105, 106, 107 added for use until January 27, 2022 and rooms 201, 202, and 101 extended to Marcauthorized by DAF 2021-340. The clinic's use of Rooms 105, 106, and 107 was further extended through 2022, authorized by DAF 2022-038.

Licensed Area: North Building, Rooms 101, 201, 202 (10,560 sq ft)

South Building, Room 401 and 501 (7,300 sq ft)

Licence Fee: \$0.00 per sq. ft. per year (plus HST)

Additional Costs: Additional Costs of cleaning, security, electrical, HVAC and telecommunications charges are estimated at

approximately \$70,000.00 (+HST) from March 20 to April 30, 2022.

Term: Rooms 101, 201, and 202 will be extended for fifteen (15) days, commencing March 20, 2022 and ending April

3, 2022.

Rooms 401 and 501 will be licensed from April 1, 2022 and ending April 30, 2022.

Permitted Use: The Licensed Areas shall be used by the City for the purpose of operating a Toronto Public Health

Immunization Clinic for the general public.

Insurance: Comprehensive liability insurance shall provide a minimum limit of liability of five million dollars (\$5,000,000) for

bodily injury and/or property damage in any one occurrence, shall include a cross-liability clause, shall name Metropolitan Toronto Convention Centre Corporation as additional insured and shall provide that it will not be

cancelled or materially altered prior to the termination of the occupancy period.

Services: Licensor to provide use of the required amount of six-foot folding tables, folding chairs, and stanchions with

rope at no charge. Setup and takedown charges are per above. Licensor to provide cleaning staff for the

washroom and common areas during clinic operation, charges per above.

Rules: The Licensor has provided its list of Operating Guidelines.

Should the actual cost of the additional services for the first threemonths of the occupancy period amount to more than the deposit, the amount of such shortfall will be paid by the Licensee with the next installment for additional services coming due.






