- 1. Muhammad Shahbaz Yousaf** (Report No. 7676)  
Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4535353

**DECISION:**

The Tribunal approved the joint Proposed Resolution signed on December 16, 2021, as follows:

"Vehicle-For-Hire Driver's Licence will be issued subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licences may be cancelled;
- (2) The Vehicle-For-Hire Driver's Licence will be placed on probation for a period of **two (2) years**. MUHAMMAD SHAHBAZ YOUSAF is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against MUHAMMAD SHAHBAZ YOUSAF and conduct other investigations, as appropriate, to assess MUHAMMAD SHAHBAZ YOUSAF's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against MUHAMMAD SHAHBAZ YOUSAF or any other concerns with respect to the conduct of the licensee, those matters and report no. 7676 and any updating material, may be brought back before the Tribunal for a full hearing."

**2. South Central Towing Inc. (Report No. 7590)**

**DECISION:**

The Tribunal approved the issuance of the Tow Truck Owner's Licences, on consent, subject to the following condition:

- (1) Mohammad Nassir Hakimi is not permitted to work for the company in any capacity, as a Manager, Employee, Driver, Officer or Director.

The Tribunal further approved the request for adjournment sine die, regarding the renewal of Mohammad Nassir Hakimi's Tow Truck Driver's Licence No. D09-4836028. The interim conditions ordered on the licence at the March 25, 2021 Tribunal Hearing will continue, until such time the Tribunal orders otherwise.
