TORONTO LICENSING TRIBUNAL ELECTRONIC HEARING: February 3, 2022 (9:30 AM) Summary of Decisions E. Montigny / A. Bakshi / D. Simon

1. Francesco Caruso (Report No. 7644) Applicant for the Renewal of Tow Truck Driver's Licence No. D09-4827064

DECISION:

The Tribunal approved the joint Proposed Resolution signed on February 3, 2022, as follows:

- "Tow Truck Driver's Licence No. D09-4827064 ("Tow Truck Driver's License") will be renewed, subject to the following conditions:
 - All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
 - (2) Tow Truck Driver's Licence will be renewed and suspended for fourteen (14) consecutive days;
 - (3) Tow Truck Driver's Licence will continue on probation until November 15, 2024. Francesco Caruso is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Francesco Caruso and conduct other investigations, as appropriate, to assess Francesco Caruso's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
 - (4) Prior to the renewals of the licence in 2022, 2023, 2024, Francesco Caruso must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
 - (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Francesco Caruso or any other concerns with respect to the conduct of the licensee, those matters and report no. 7644 and any updating material, may be brought back before the Tribunal for a full hearing."

The Tribunal approved the joint Proposed Resolution signed on February 3, 2022, as follows:

"The Motorized Refreshment Vehicle Licences will be issued effective immediately subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 60 days of the Tribunal hearing, failing which the Licences may be cancelled;
- (2) The Licences will be placed on probation for a period of two (2) years. The Licensee is advised that during the probationary period, MLS may make additional checks of any driving, criminal and by-law charges and convictions against the Licensee and its director, and conduct other investigations, as appropriate, to assess the Licensees' compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against the Licensee, their director, or any other concerns with respect to the conduct of the Licensee and their director, those matters and report no. 7661 and any updating material, may be brought back before the Tribunal for a full hearing."
