DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on April 19, 2022, as follows:

"Public Garage Licence will be issued, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being issued, Public Garage Licence will be placed on probation for a period of two (2) years. Ibrahim Muhamed Sayed and Unous Mohammad Dawud are advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Flex Auto Care & Detailing Inc., Ibrahim Muhamed Sayed and Unous Mohammad Dawud and conduct other investigations, as appropriate, to assess the compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next two (2) renewal(s) of the licence, Flex Auto Care & Detailing Inc. must provide to Municipal Licensing and Standards, at its own expense, an original up-to-date abstract of Ibrahim Muhamed Sayed's Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Flex Auto Care & Detailing Inc., Ibrahim Muhamed Sayed and Unous Mohammad Dawud or any other concerns with respect to the conduct of the licensee, those matters and report no. 7718 and any updating material, may be brought back before the Tribunal for a full hearing."

2. Ahmed Ashaqzai (Report No. 7714)

Applicant for the Renewal of Tow Truck Driver's Licence No. D09-4670706

DECISION:

The Tribunal approved the joint Proposed Resolution signed on April 21, 2022, as follows:

"Tow Truck Driver's Licence No. D09-4670706 ("Tow Truck Driver's License") will be renewed, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Tow Truck Driver's Licence will be placed on probation for a period of two (2) years. Ahmed Ashaqzai is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Ahmed Ashaqzai and conduct other investigations, as appropriate, to assess Ahmed Ashaqzai's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next two (2) renewals of the licence, Ahmed Ashaqzai must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Ahmed Ashaqzai or any other concerns with respect to the conduct of the licensee, those matters and report no. 7714 and any updating material, may be brought back before the Tribunal for a full hearing."
