# Watermain Replacement on Fairmeadow Avenue from Fairmeadow Avenue to Yorkminster Road; and Yorkminster Road from Fairmeadow Avenue to Lord Seaton Road

Contract: 22ECS-LU-07SU Start Date: May 2022 End Date: December 2022 \*Timeline is subject to change.

The City of Toronto plans to replace the watermain and the City-owned portion of substandard water services on Fairmeadow Avenue from Fairmeadow Avenue to Yorkminster Road; and Yorkminster Road from Fairmeadow Avenue to Lord Seaton Road.

The water service is the underground pipe that brings water to your water meter and is owned by you <u>and</u> by the City. The part you own is from your house to the end of your property, the part the City owns is from the end of your property to the watermain.

This project is part of the Council-approved 2022 Capital Works Program to renew our aging infrastructure, improve water distribution and reduce the risk of watermain breaks.


## IMPORTANT INFORMATION ABOUT COVID-19 AND CONSTRUCTION WORK IN TORONTO

Please read the attached fact sheet with important information about the risks of lead in drinking water, especially if someone in your house is pregnant, there are children under six years old, or there is an infant drinking formula made using tap water.

# WHAT TO EXPECT BEFORE CONSTRUCTION

- Work crews will mark the locations of underground utilities, such as gas, water and cable so that the construction work does not interfere with these utilities.
- Affected properties will receive a Construction Notice approximately two weeks before work begins with more information about the work.
- The City will not be responsible for damage to any privately owned items on City property.
