DECISION:

The Tribunal issued the following order:

"In the matter of Kabi Auto Inc., Report No. 7461, operating as Luxury Roadside Assistance, Kabillan Vikneswaran, President, Holder of Tow Truck Owner's Licence No. V10-4947379; and Applicant for Two Truck Owner's Licence Application No. C010121; and Kabillan Vikneswaran, Applicant for the Renewal of Tow Truck Driver's Licence No. D09-4541219.

There are a number of other licences that have been mentioned in the Report but we have been advised by Counsel for MLS, Ms. Murakami, that those licences have expired since this matter commenced and they are therefore cancelled and no longer before the Tribunal.

In a letter dated yesterday, May 11, 2022, Mr. Mitchell, paralegal for the Applicants and Licensees, requested an adjournment of this matter.

This matter has already been adjourned five times and today's hearing date was marked peremptory to the Licensees and Applicants. That means that the matter was scheduled to go ahead today. However, another adjournment has been requested today by the Licensees and Applicants. In light of the history of this Report before the Tribunal, the Tribunal adjourns the matter to July 28, 2022 at 9:30 a.m., peremptory to Kabi Auto Inc. and Kabillan Vikneswaran. The matter will proceed on that date. If the parties are not in attendance on July 28, 2022 and ready to proceed, the matter will be dismissed.

All documents to be introduced by Kabi Auto Inc. and Kabillan Vikneswaran, at the hearing are to be provided to MLS by July 18, 2022. If the documents are not provided by that date, the Licensees and Applicants will not be allowed to introduce them in evidence before the Tribunal."
