Land Acknowledgement

We acknowledge the land we are meeting on is the traditional territory of many nations including the Mississaugas of the Credit, the Anishnabeg, the Chippewa, the Haudenosaunee and the Wendat peoples and is now home to many diverse First Nations, Inuit and Métis peoples. Funding Overview

Funding Objective

Facilitate housing options and supports for diverse communities through funding partnerships that:

- provide a range of opportunities for non-profit, community based organizations to provide a variety of housing supports and homelessness services to residents
- build and strengthen a responsive, housing-focused and people-centered homelessness service system, while shifting towards more sustainable, permanent, affordable housing solutions
- Specific prioritization of Indigenous and Black projects and organizations

Homelessness Services

- The Housing TO 2020-2030 Action Plan's key objective is to improve housing outcomes for current and future residents of Toronto
- Strategic Direction 3: Prevent Homelessness and Improve Pathways to Housing Stability
 - Ensure an effective and housing-focused emergency response to homelessness
 - Rare, brief and non-recurring
 - Better connect people experiencing homelessness to housing and supports
 - Develop strategies and programs that meet the needs of specific populations



Goals

Funded programs will aim to:

- Enhance service quality and impact through ongoing performance management
- Increase housing stability for people exiting homelessness or at risk of homelessness
- Work collaboratively with the City to ensure targets and key deliverables are met

Funding and Term

- The funding available in the category is approximately 1.8 Million annually
- The project term is 2.5 years (October 1, 2022 – March 31, 2025)
- All project proposals are received through the Toronto Grants Rebates and Incentives Portal (TGRIP)
- Materials and Instruction will be provided.
- TGRIP and Application Sessions will be held separately

Proposal Content

- The outcomes and targets are clear and achievable
- The quality of the Work Plan, including timelines, shows an understanding of the scope of the work
- Financial stability and oversight
- Demonstrate experience in collective impact, building community partnerships
- Experience and Capacity to work with people with histories of homelessness
- Willingness to increase knowledge and skills through participation in training opportunities

Assessment Process

- The Grant team is committed to ensuring that all proposals received are evaluated using a Housing First, Human Rights, Harm Reduction, People-Centred and Equity lens
- These principles are based on the SSHA Service Plan, Meeting in the Middle Engagement Strategy and Action Plan to Confront Anti-Black Racism
- Project Applications received will be ranked in the Toronto Grants, Rebates and Incentives Portal (TGRIP)
- Supplementary Evaluation Tools will be created for review panels in consultation with SSHA and City Indigenous and Confront Anti-Black Racism unit experts

Project Types

1. Sector capacity building and coordination
 - Networks that support a coordinated housing and homelessness service system
 - Training and capacity building for staff across the sector
2. Specific system wide client supports



Sector Capacity Building and Coordination

Who Should Apply?

- Eligible applicants are non-profit organizations that have the skills and experience to engage service providers.
- Applicants must demonstrate that they have the necessary resources, expertise and experience to facilitate the coordination and development of system wide strategic responses and foster new approaches to addressing system wide issues.

What are Sector Capacity Building and Coordination projects?

- Provide services to the housing and homelessness service sector as a whole.
- Strengthen the organizational capacity of service providers and other housing and homelessness sector-organized groups.
- Facilitate system wide coordination, training, resource sharing and development of networks for stronger linkages and relationships between organizations.
- Facilitate the coordination and development of system wide strategic responses and foster new approaches to addressing system wide issues.
- Support a group of service providers to better integrate and synchronize their services and processes.

Networks that Support a Coordinated Housing and Homelessness Service System

- Networks designed to support a coordinated housing and homelessness service system should offer specific supports and benefits to the sector as a whole, or to a specific subset of providers
- Activities could include (but are not limited to):
 - Supporting providers with staff recruitment and hiring
 - Support for using best practices to hire and work with people with lived and living experience of homelessness
 - Developing mental health and wellness resources for sector staff
 - Developing best practices and shared resources for the sector
 - Sector-wide strategic planning and policy development

Training and Capacity Building for Staff Across the Sector

- Training and capacity building opportunities should be made available to staff across the sector
- Training topics could include (but are not limited to):
 - Confronting Anti-Black racism
 - Gender Inclusion
 - Housing First
 - Harm Reduction
 - Trauma informed services
 - Working with specific populations of people experiencing homelessness

Service Delivery Requirements

- Engage and collaborate with sector
- Coordinate and deliver services for sector
- Improve sector service planning
- Build stronger partnerships
- Improve integrated services

Service Delivery Requirements (cont'd)

- Increase sector wide knowledge and resources
- Specify network mandate and eligibility criteria
- Enhance sector capacity to deliver services
- Provide accessible, coordinated and streamlined services



Specific System Wide Client Supports

Who Should Apply?

- Successful applicants provide people with specific services, as needs arise to facilitate housing access and stability.
- If your project provides these services through a case management model, you must apply under one of the client case management categories.

What are Specific System Wide Client Supports projects?

- Specific System Wide Client Supports projects help organizations to better serve their clients by providing shared access to both material resources and human resources.
- They provide essential services to individuals and households experiencing or at risk of homelessness.
- These specialized supports are delivered as individual needs arise and **do not include case management.**

What types of Specific System Wide Client Supports projects will be prioritized?

Examples of these projects could include (but are not limited to) supporting clients with access to:

- Improved unit conditions
- Communication supports
- Resources to facilitate transitions to housing
- Mental health and harm reduction supports and education
- Peer supports

Service Delivery Requirements

- Provide non-judgemental, trauma-informed and anti-oppressive services rooted in harm reduction and Housing First approaches
- Be flexible and mobile
- Coordinate with system partners (e.g. landlords, housing providers, drop-in services, healthcare services, etc.)
- Provide a clear service delivery plan

TGRIP – Eligibility Checklist

▼ Eligibility Checklist

The following eligibility requirements must be satisfied in order to apply for this funding opportunity:

- a. the organization shall be 1) located within the boundaries of the City of Toronto, or 2) an urban off-reserve Indigenous-led organization located in the City of Toronto who may also provide culturally-based programming outside the boundaries of the City of Toronto;
- b. the services funded through the grant shall take place within the boundaries of the City of Toronto, with the exception of services being delivered by urban off-reserve Indigenous-led organizations, that yield direct benefits for the urban Indigenous communities of Toronto;
- c. the organization shall provide information which demonstrates that it does not, in the absence of the grant, have the financial resources necessary to undertake the activity for which the grant is requested;
- d. the organization shall have legal not-for-profit or charitable status or be an urban off-reserve Indigenous-led organization;
- e. the organization shall not be or have been indebted to the City or be in default of the terms and conditions of any agreement (including any previous grant agreement) with any division, agency, board or commission of the City of Toronto under the discretion of the Division Head;
