The City of Toronto is planning to resurface Cannon Road. Our inspection of the road shows that it needs repaving.

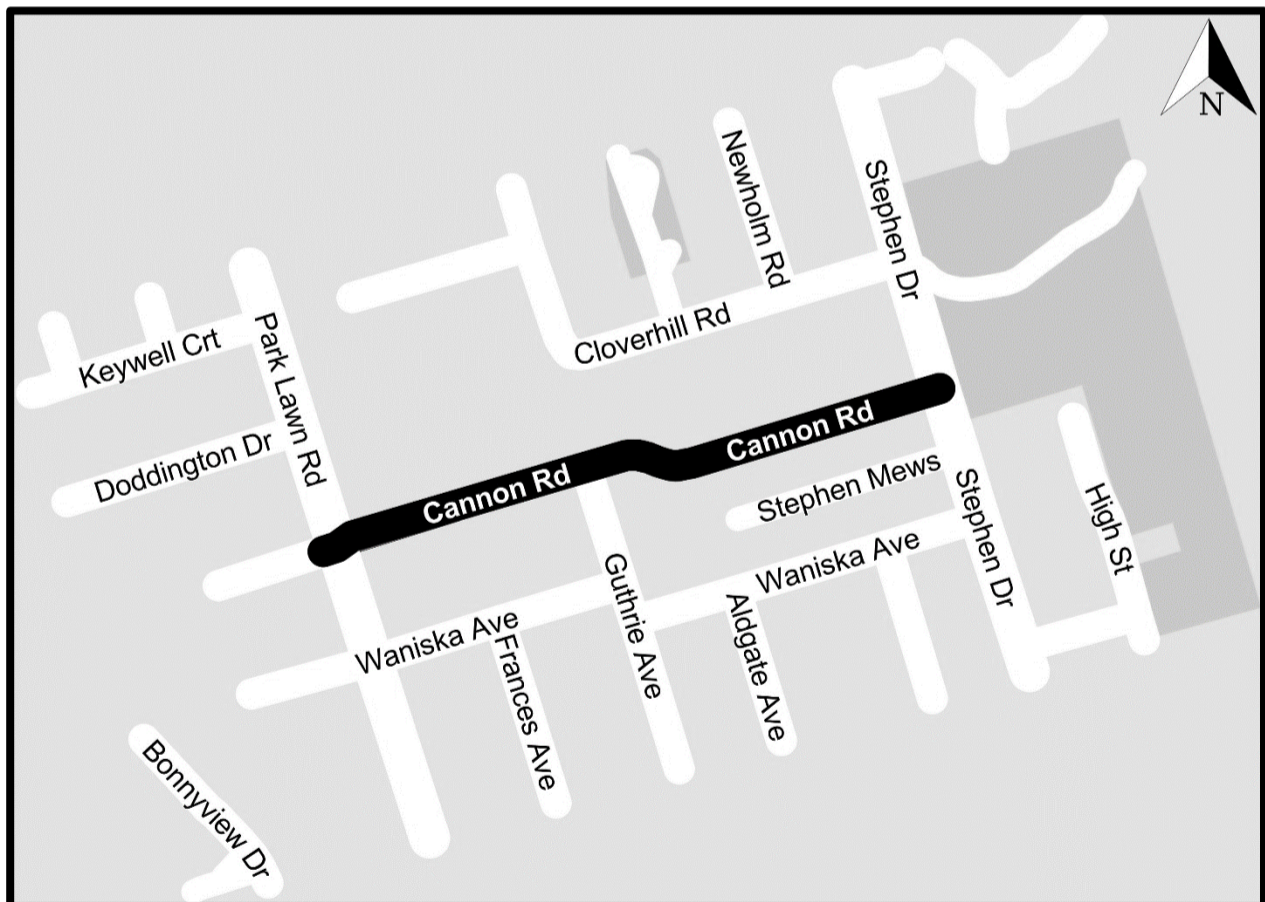
The City of Toronto is planning to install french drains within the City's boulevard. French drains are a form of green infrastructure designed to capture and filter stormwater close to where it falls, reducing the overall volume of stormwater that enters the City's sewer system and improving the quality of runoff before it makes its way into local waterways. Once installed these systems are virtually invisible and resemble a naturally landscaped grassed area.

This project is part of the Council-approved 2022 Capital Works Program to renew aging City roads and sidewalk for current and future needs.

WHAT TO EXPECT BEFORE CONSTRUCTION

- Work crews will mark sidewalks and curbs requiring replacement and the locations of underground utilities, such as gas, water and cable so that the construction work does not interfere with these utilities.
- Affected properties will receive a Construction Notice approximately two weeks before work begins with more information about the work.
- The City will not be responsible for damage to any privately owned items on City property.

	<p>Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the Project Manager listed below.</p>

Property owners should remove items located within City property limits (boulevard) to avoid damage.</p> <p>This includes items such as landscaping (plants and pavers), decorative objects, sprinkler systems or heated driveways.
