The parties to this agreement understand that this agreement becomes null and void upon the suspension or revocation of the owner’s licence or in the event that any licence held by the Taxicab Operator is suspended, revoked or placed under a condition that prohibits functioning as a Taxicab Operator.

The parties further understand and agree that a taxicab owner and taxicab operator shall, at all times and notwithstanding any agreement to the contrary, be jointly responsible for ensuring the taxicab owned by the taxicab owner and managed or controlled by the taxicab operator is maintained and managed in a manner that complies with the requirements of Chapter 546, City of Toronto Municipal Code.

7. This notice is made pursuant to Section 546-63 of the said Article 6, Chapter 546, City of Toronto Municipal Code and is the subject to the provisions of such Code.
