C2K at RESCON's Housing Supply Summit 2.0

The Residential Construction Council of Ontario (RESCON) is hosting a free [virtual conference](#) to provide insight into the housing crisis and discuss whether there have been improvements made since they held their first event on the issue in March. [Housing Supply Summit 2.0: Progress Report](#) will take place on Thursday, October 6 from 1 to 5 p.m.

C2K's Kris Hornburg, Director, Development Process & Performance, will take part in a panel called **Outstanding Housing Reforms Needed to Increase Supply**, from 2:55 p.m. to 3:25 p.m. The panel will discuss what changes are required to increase housing supply and how they will complement reforms already made. Application Submission Tool Change Agent Network

C2K is creating an Application Submission Tool Change Agent Network to provide you with opportunities to take on an advisory role to help influence positive and sustainable changes within development review. As a change ambassador, you will support a range of activities, including cascading formal and informal communication to your colleagues, inspiring positive behavioural changes, shaping the culture, etc. We would also like to capture your input on how to further enhance the Application Submission Tool (AST) to support a predictable, transparent and timely development review application intake process.

Deep Retrofit Challenge

Applications are now open for the City's Deep Retrofit Challenge. Through the Challenge, the City will provide funding to support deep energy retrofits in 10 to 16 buildings. Retrofits must reduce total energy use intensity and greenhouse gas emissions by at least 50 per cent. Participants will receive a grant equal to 25 per cent of their total project costs up to a maximum of \$500,000 (depending on gross floor area and performance) to offset the incremental design and construction costs required to maximize emissions reductions. Buildings must be located within Toronto and be an Ontario Building Code Part 3 building (i.e., greater than 600m² or greater than three storeys). Retrofits must be completed by January 31, 2025.
