## TORONTO LICENSING TRIBUNAL ELECTRONIC HEARING: October 20, 2022 (9:30 AM) Summary of Decisions M. Lee

1. Tariq M. Khan (Report No. 7675) Holder of Vehicle-For-Hire Driver's Licence No. D01-4653531

## **DECISION:**

The parties requested an adjournment of this matter. The Tribunal approved the request for adjournment to Mach 9, 2023 at 9:30 a.m., on consent.

The Tribunal further ordered the following interim condition placed on Mr. Khan's Vehicle-For-Hire Driver's Licence at the January 20, 2022 Tribunal Hearing will continue, until such time the Tribunal orders otherwise:

(1) Mr. Khan must report any new charges or convictions under the Criminal Code of Canada to Municipal Licensing and Standards in writing, via email to <u>mlsconditionreporting@toronto.ca</u>.

2. Guohua Xie (Report No. 7325)

Holder of Holistic Practitioner Licence No. T30-4671106

## **DECISION:**

The Tribunal approved the joint Proposed Resolution, originally signed on October 6 (by Mr. Xie) and October 14, 2022 (by Municipal Licensing and Standards), as follows:

"Holistic Practitioner's License [*sic*] No. T30-4671106 will be renewed, subject to the following conditions:

 All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;

- (2) Immediately upon being renewed, the Holistic Practitioner's License [sic] will be placed on probation for a period of 2 years. Guohua Xie is advised that during the probationary period, MLS may make additional checks of any criminal, and by-law charges and convictions against Guohua Xie and conduct other investigations, as appropriate, to assess Guohua Xie's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Guohua Xie or any other concerns with respect to the conduct of the licensee, those matters and report no. 7325 and any updating material, may be brought back before the Tribunal for a full hearing.
- (4) Prior to each of the next two (2) renewal(s) of the licence, Guohua Xie must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (5) During the probationary period, if Guohua Xie incurs any new charges or convictions under the Criminal Code of Canada, he must notify Municipal Licensing and Standards, in writing, within three (3) business days which can be done in one of the following ways:
