**1. Mohamed Akil Bacchus (Report No. 7213)**

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4692656  
AND

Holder of Taxicab Owner's Licence No. V02-3129389, Plate No. A381

**DECISION:**

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"Taxicab Owner's Licence be issued with no conditions and the Vehicle-For-Hire-Driver's Licence be renewed subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 60 days of the Tribunal hearing, failing which the licences may be cancelled;
- (2) The Vehicle-For-Hire-Driver's Licence will be placed on probation for a period of **One (1) year**. MOHAMED AKIL BACCHUS is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against MOHAMED AKIL BACCHUS and conduct other investigations, as appropriate, to assess MOHAMED AKIL BACCHUS's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next renewal of the licence, MOHAMED AKIL BACCHUS must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against MOHAMED AKIL BACCHUS or any other concerns with respect to the conduct of the licensee, those matters and report no. 7213 and any updating material, may be brought back before the Tribunal for a full hearing."

**2. De Vaughn Alex Joseph-Watson (Report No. 7768)**  
Applicant for a Tow Truck Driver's Licence (Application No. C227219)

**DECISION:**

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"Tow Truck Driver's Licence will be issued, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licences may be cancelled;
- (2) Upon being renewed, the Tow Truck Driver's Licence will be placed on probation for a period of three (3) years. De Vaughn Alex Joseph-Watson is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against De Vaughn Alex Joseph-Watson and conduct other investigations, as appropriate, to assess De Vaughn Alex Joseph-Watson's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against De Vaughn Alex Joseph-Watson or any other concerns with respect to the conduct of the licensee, those matters and report no. 7768 and any updating material, may be brought back before the Tribunal for a full hearing."
