### Maple Sanitary Trunk Sewer Rehabilitation Sewer in G Ross Lord Park Ravine from Steeles Avenue to G Ross Lord Reservoir

#### Contract: 21ECS-LU-02TT Start Date: February 2023 End Date: September 2024 \*Timeline is subject to change.

The City of Toronto is planning to rehabilitate the Maple Sanitary Trunk Sewer (STS). The Maple STS is located within the G Ross Lord Park Ravine, running parallel to the Don River West Branch from Steeles Avenue to the G Ross Lord Reservoir. The sanitary trunk sewer is an underground pipe that collects wastewater from sewers and delivers it to wastewater facilities for treatment.

This project is part of the Council-approved 2021 Capital Works Program to renew the City's aging sewer infrastructure and will extend the service life of the trunk sewer section by approximately 50 years.

#### WHAT TO EXPECT BEFORE CONSTRUCTION

- Work crews will mark the locations of underground utilities, such as gas, water and cable so that the construction work does not interfere with these utilities.
- Affected properties will receive a Construction Notice approximately two weeks before work begins with more information about the work.
- The City will not be responsible for damage to any privately owned items on City property.

Ġ	<b>Accessible Accommodation:</b> The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the Project Manager listed below.

Affected properties will receive a request to schedule a time to complete the pre- construction condition survey. <b>M</b>	Important information for owners of sprinkler systems / heated driveways and private landscaping features. Property owners should remove items located within City property limits (boulevard) to avoid damage.
<u>aa aa</u> aa aa	This includes items such as landscaping (plants and pavers), decorative objects, sprinkler systems or heated driveways. If you have a sprinkler system or heated driveway, please contact the Project Manager listed below.
