## Overnight Watermain Work on Scott Street from The Esplanade to Front Street East

**Contract: 21ECS-LU-08TT**

**Start: Wednesday, November 16, 2022 (7:00 p.m.)**

**End: Friday, November 18, 2022 (6:00 a.m.)**

*Timeline is subject to change.*

The City of Toronto's watermain work on Scott Street continues. This notice is to provide an update on the watermain installation and some further required evening work.

This work will occur during the nighttime to minimize impacts on daytime activities, avoid disruptions to traffic (i.e. full road closures), allow deliveries and accommodate local businesses, as well as keeping work on schedule. Weather permitting, this work will be performed on consecutive nights.

From **Wednesday, November 16 at 7 p.m. until Thursday, November 17 at 6 a.m.**, the contractor will carry out excavation to install the new watermain infrastructure and connections on **Scott Street**. A water shutoff will be required for some properties on or about Wednesday, November 16<sup>th</sup>, and affected properties and businesses will be notified in a separate notice.

From **Thursday, November 17 at 7 p.m. until Friday, November 18 at 6 a.m.**, the contractor will carry out excavation to install the new watermain infrastructure and connections on **The Esplanade**. A water shutoff will be required for some properties on or about Thursday, November 17<sup>th</sup>, and affected properties and businesses will be notified in a separate notice.

The contractor is being permitted to work 24 hours a day until the work is completed and to perform the necessary work overnight if necessary.

The contractor will make every attempt to minimize disruption to residents and businesses by scheduling most work between 7:00 p.m. and 11:00 p.m. When the necessary overnight work is completed, regular construction hours will resume.

Weather conditions may also affect the progress of this work. Your patience and understanding are appreciated during these disruptions.



### WHAT TO EXPECT DURING CONSTRUCTION

- Heavy equipment (eg. Hydrovac, saw cutting, drilling, et.) will be operated during the construction period, and you may experience dust, noise and other inconveniences.
- Please note that all construction vehicles are equipped with mandatory backup warning/signalling beepers. These devices are required for the safety of construction crews and cannot be disabled.
- The City will not be responsible for damage to any privately-owned items on City property, so please ensure that you remove/arrange for the removal of such items.



**Road and Sidewalk Access:** To complete the work in a safe manner, there will be road and sidewalk restrictions within the work zone. Access for emergency vehicles will be maintained at all times.

# Notice of Overnight Work

	<p><b>Driveway Access:</b> The contractor will notify you of any temporary restrictions to driveway access. This overnight work will allow the contractor to install and cross both Scott Street lanes and the underground parking garage in one operation, minimizing impacts to local stakeholders.</p>
	<p><b>Traffic Management:</b> Traffic on Scott Street has been reduced to one south-bound lane from Front Street East to The Esplanade to accommodate this project. There is no on-street parking permitted on Scott Street during the construction period. Road users should expect delays and increased traffic on nearby streets. Motorists are reminded that bicycles and cars will be sharing the same traffic lane. When driving, please be mindful of other road users.</p>
	<p><b>Accessible Accommodation:</b> The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the <b>Field Ambassador</b> listed below.</p>
